15 WHEREAS, on November 10, 2021, the City of Hallandale Beach released Request for
16 Proposals (RFP) #FY2021-2022-002 Classification and Compensation Study. Notice for the RFP
17 was sent via email to over eight hundred and fifty (850) vendors including vendors from the City's
18 Vendor list; and

20 WHEREAS, on November 22, 2021, an in-person non-Mandatory Pre-Proposal
21 Conference was held. No firms attended; and

23 WHEREAS, on January 6, 2022, the City received one (1) response to the RFP solicitation
24 from Manpower Group; and

26 WHEREAS, on January 26, 2022, the Evaluation Committee held an in-person meeting
27 to evaluate the single proposal received; and

29 WHEREAS, upon the Evaluation Committee's review of the vendor's submittal of
30 documentation with the minimum requirements of the RFP, it was unanimously determined that
31 the vendor's submittals did not meet the minimum qualification requirements for items #2a, #2c
32 and #2d; and

34 WHEREAS, City Administration seeks City Commission authorization to reject the lone
35 submitted proposal and authorize the City Manager to proceed in the best interest of the City for
36 procuring the required services.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF
THE CITY OF HALLANDALE BEACH, FLORIDA:**
