5 **COMMISSION OF THE CITY OF HALLANDALE**
6 **BEACH, FLORIDA, AUTHORIZING UTILIZATION OF**
7 **THE CITY OF CORAL SPRINGS'S AGREEMENT WITH**
8 **CARUS, LLC PURSUANT TO BID # 22-C-268F, TO**
9 **PROCURE SODIUM HEXAMETAPHOSPHATE (SHMP)**
10 **FOR FISCAL YEAR 2024-25 IN A TOTAL NOT TO**
11 **EXCEED AMOUNT OF ONE HUNDRED, SEVENTY-**
12 **FIVE THOUSAND DOLLARS (\$175,000); AND**
13 **PROVIDING AN EFFECTIVE DATE.**

16 **WHEREAS,** pursuant to Chapter 23, Section 23-8 Exception to Bid
17 Requirements, (6) Bids and Contracts from Other entities, and Section 23-9
18 Cooperative Purchasing, the City Manager is authorized to procure supplies,
19 materials, equipment, and services from other governmental units, when the best
20 interests of the City would be served subject to the requirement that any purchase in
21 excess of \$50,000 requires City Commission approval; and

23 **WHEREAS,** Sodium Hexametaphosphate (SHMP) is required in City's water
24 plant lime plant filters because it is an excellent deflocculant, which helps to prevent
25 the forming of large deposits in the filters and facilitates cleaning the filters in the filter
26 backwash process; and

28 **WHEREAS,** the City of Coral Springs is under contract with Carus, LLC
29 pursuant to BID # 22-C-268F, through which that City procures Sodium
30 Hexametaphosphate (SHMP); and

32 **WHEREAS,** Staff recommends that the Mayor and City Commission find it in
33 the public interest to authorize utilization of the City of Coral Springs's agreement with
34 Carus, LLC pursuant to BID # 22-C-268F to procure Sodium Hexametaphosphate
35 (SHMP) for Fiscal Year 2024-25 in a total not to exceed amount of One Hundred,

Seventy-Five Thousand Dollars (\$175,000), and authorize the City Manager to execute related documents to effectuate the purchase.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The foregoing "Whereas" clauses are incorporated herein.

SECTION 2. The Mayor and City Commission hereby authorize utilization of the City of Coral Springs's agreement with Carus, LLC pursuant to BID # 22-C-268F, to procure Sodium Hexametaphosphate (SHMP) for Fiscal Year 2024-25 in a total not to exceed amount of One Hundred, Seventy-Five Thousand Dollars (\$175,000), and authorize the City Manager to execute related documents to effectuate the purchase.

SECTION 3. This Resolution shall take effect immediately upon its passage and adoption.

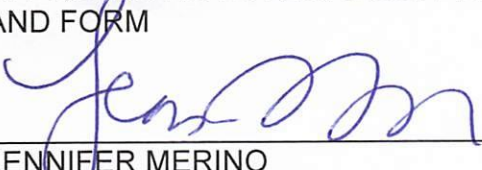
