RESOLUTION NO. 2017 -

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF
THE CITY OF HALLANDALE BEACH, FLORIDA,
AUTHORIZING THE CITY MANAGER TO EFFECTUATE THE
NECESSARY PURCHASE OF BUILDING AND EQUIPMENT
MAINTENANCE AND REPAIR SUPPLIES UTILIZING
NATIONAL JOINT POWERS ALLIANCE CONTRACT #091214-
WWG IN AN AMOUNT NOT TO EXCEED SEVENTY SIX
THOUSAND SIX HUNDRED DOLLARS (\$76,600) AS
BUDGETED FOR IN FISCAL YEAR 2017-2018; AND
PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 23-9 of the City of Hallandale Beach ("City") Code, the City Manager shall have the authority to join with other units of government in cooperative purchasing plans or to purchase pursuant to formal written contracts or competitive bids of other governmental units, when the best interests of the City would be served, subject to the requirement that purchases in excess of \$50,000 require City Commission approval; and

WHEREAS, The City has been utilizing the National Joint Powers Alliance (NJPA) Contract Number 091214-WWG with W.W. Grainger, Inc., to purchase building and equipment maintenance, repair and operating supplies; and

WHEREAS, authorized City staff receive a log in to utilize the Grainger contracted pricing and make purchases on-line. Some of the purchases made by departments are electrical supplies, mechanical equipment, hand soap, sump pumps, incandescent light bulbs, mats of all kinds and other related items on-line; and

WHEREAS, the Mayor and City Commission have determined that it is in the best interest of the City and its residents to authorize the City Manager to utilize the National Joint Powers Alliance (NJPA) Contract Number 091214-WWG with W.W. Grainger, Inc., to purchase building and equipment maintenance, repair and operating supplies budgeted for in Fiscal Year 2017-2018.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

41 **SECTION 1. City Manager Authorization.** The Mayor and City Commission
42 hereby authorize the City Manager to utilize the National Joint Powers Alliance (NJPA)
43 Contract Number 091214-WWG with W.W. Grainger, Inc., to purchase building and
44 equipment maintenance, repair and operating supplies in an amount not to exceed
45 seventy six thousand six hundred dollars (\$76,600.00) and authorizing the City Manager
46 to execute all related documents to effectuate the purchase.
