3	A RESOLUTION OF THE CHAIR AND BOARD OF DIRECTORS OF THE

5	AWARDING A COMMERCIAL INTERIOR RENOVATION GRANT IN THE
6	AMOUNT OF \$40,000 AND A TENANT RENT SUBSIDY GRANT IN THE
7	AMOUNT OF \$15,402 TO BARREL WINE AND CHEESE LLC; AUTHORIZING THE EXECUTIVE DIRECTOR AND HBCRA ATTORNEY
8 9	TO NEGOTIATE AND FINALIZE THE GRANT AGREEMENTS
9 10	BETWEEN THE HALLANDALE BEACH COMMUNITY
10	REDEVELOPMENT AGENCY AND BARREL WINE AND CHEESE LLC;
12	AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE THE
13	GRANT AGREEMENTS; AUTHORIZING THE EXECUTIVE DIRECTOR
14	TO TAKE ALL ACTION NECESSARY TO IMPLEMENT THE TERMS OF
15	THE GRANT AGREEMENTS AND PROVIDING AN EFFECTIVE DATE.
16	WHEREAS, the mission of the Hallandale Beach Community Redevelopment Agency
17	("HBCRA") is to promote economic development and enhance the quality of life by eliminating
18	and preventing blighted conditions through the facilitation of community partnerships, business
19	growth, job creation, and neighborhood rehabilitation; and
20	WHEREAS, the promotion of the Community Redevelopment Area and the use of tax
21	increment funds therefore falls within the purposes of the Community Redevelopment Act set
22	forth in Part III, Chapter 163, Florida Statues; and
23	WHEREAS, businesses in the Northeast Quadrant are eligible to apply for funding from
24	several HBCRA business incentive programs and, to receive the maximum amount of funding, an
25 26	applicant must be located within one of the HBCRA "Priority Areas;" and
27	WHEREAS, on June 26, 2023, HBCRA staff met with Allison Sarbin, the owner of Barrel
28	Wine and Cheese LLC, for the submittal of the HBCRA Commercial Business Grant (CBG),
29	Commercial Interior Renovation Grant (CIRG), and the Tenant Rent Subsidy Grant (TRSG)
30 31	applications; and
32	WHEREAS, since meeting with HBCRA staff, Barrel Wine and Cheese LLC executed a
33	10-year lease to occupy the ground floor commercial space of ArtSquare located at 419 N Federal
34	Highway, Hallandale Beach, Florida, and plans to renovate the interior commercial space to
35 36	create a unique wine bar/lounge called Barrel Wine & Cheese, which will provide a moderately priced menu of fine wine & gourmet cuisine for lunch and dinner; and
37	priced mend of the whe & gourner cuisine for funch and diffier, and
38	WHEREAS, Barrel Wine & Cheese LLC has applied for the CBG, CIRG, and TRSG
39	programs, which will help offset some of their investments in transforming the existing space into
40 41	a restaurant, including a kitchen area, bar, and dining/lounge area; their total investment cost is \$850,800 for interior renovations, furnishing, wine dispensers, and POS equipment; and
41 42	wood, ood tor interior renovations, runnishing, wine dispensers, and FOS equipment, and
43	WHEREAS, based on its location in the Community Redevelopment Area, Barrel Wine
44	and Cheese LLC is eligible for the CIRG and TRSG; and

45 46 **WHEREAS,** HBCRA Staff recommends that the Board of Directors of the HBCRA award 47 a HBCRA Commercial Business Incentive package to Barrel Wine and Cheese LLC for the 48 renovation of the commercial floor space at 419 N Federal Highway, which incentives will include 49 a CIRG in the amount of \$40,000 and a TRSG in the amount of \$15,402, totaling \$55,402 in 50 commercial incentives; and

52 **WHEREAS,** the Board of Directors of the HBCRA desires to approve a Commercial 53 Interior Renovation Grant in the amount of \$40,000 and a Tenant Rent Subsidy Grant in the 54 amount of \$15,402 to Barrel Wine and Cheese LLC for the renovation of commercial floor space 55 and rent subsidy, and in order to alleviate slum and blighted conditions.

66 Section 3. <u>Negotiation and Finalization of the Grant Agreements</u>. The Executive Director 67 and HBCRA Attorney are hereby authorized to negotiate and finalize the Grant Agreements with 68 Barrel Wine and Cheese LLC.

Section 4. <u>Execution of the Grant Agreements and Memorandum of Grant Agreements</u>.
 The Executive Director is hereby authorized to execute and deliver the Grant Agreements and
 Memorandum of Grant Agreements.

Section 5. <u>Implementation of Grant Agreement</u>. The Executive Director is hereby
 authorized to take all steps necessary and appropriate to implement the terms and conditions of
 the Grant Agreements.

75 Section 6. <u>Effective Date</u>. This resolution shall take effect immediately upon approval.
