16	WHEREAS, pursuant to Section 23-6, Award of Contracts, and 23-8, Unique
17	Circumstances, the City Commission may declare unique circumstances as an exception to
18	the requirements of competitive bidding;

20	WHEREAS, unlike the procurement of most services, insurance products must be
21	obtained through a broker who is paid a commission by the insurance company and not the
22	city;
23	
24	WHEREAS, the City participates in the Florida Municipal Insurance Trust Fund, which
25	is administered by the Florida League of Cities and limited only to municipalities, to insure its
26	physical facilities; and
27	
28	WHEREAS, this trust fund provides property insurance for all City facilities which
29	currently totals \$118,599,948. There is a \$25,000 deductible per incident except for
30	windstorm damage, which is 5% per value of the building deductible; and
31 32	WHEREAS, the property insurance for all City facilities provided by this trust fund
33	represents the cost to replace damaged property with property of like kind and quality; and

35	WHEREAS, the City Administration is recommending that the City renew its current
36	property insurance with Florida Municipal Trust Fund for the total sum of two million one
37	hundred sixty-three thousand eight hundred and forty-five (\$2,163,845) Dollars for fiscal year
38	2023-2024; and

41	current property insurance through the Florida I	Municipal Insurance Trust Fund.
