**A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
AUTHORIZING UTILIZATION OF THE CITY OF MILTON, FL -  
RFP #2017.10.014 AGREEMENT WITH ENCO UTILITY  
SERVICES LLC IN AN AS NEEDED AMOUNT NOT TO  
EXCEED NINETY-SIX THOUSAND, SEVEN HUNDRED  
DOLLARS (\$96,700) FOR FY 2024-25; AND PROVIDING FOR  
AN EFFECTIVE DATE.**

14       **WHEREAS**, pursuant to Section 23-8 (6) of the City of Hallandale Beach Code of  
15 Ordinances, the City Commission may utilize competitively bid contracts by other  
16 governmental agencies to procure supplies, materials, equipment and services when the best  
17 interests of the City would be served, and pursuant to Section 23-9, it may join with other  
18 units of government in cooperative purchasing plans; and

20       **WHEREAS**, the benefits of continuing to contract with a commercial printer include  
21 reducing bill printing costs in multiple ways, such as economies of scale, efficiency and  
22 automation, reduced equipment and maintenance costs, and minimized errors and waste;  
23 and

25       **WHEREAS**, previously, the City Commission of Hallandale Beach had authorized  
26 expenditures for ENCO Utility Services LLC under the Florida Municipal Power Agency's  
27 (FMPA) piggyback agreement, which expired on November 30, 2024; and

29       **WHEREAS**, on March 1, 2018, the City of Milton, Florida, entered into an agreement for  
30 printing services with ENCO Utility Services LLC, and that agreement was renewed for an  
31 additional year in April of 2025; and

33       **WHEREAS**, Staff recommends that the Mayor and City Commission find it to be in the public  
34 interest to authorize utilization of the City of Milton, FL - RFP #2017.10.014 agreement with  
35 ENCO Utility Services LLC in an as needed amount not to exceed Ninety-Six Thousand,

36 Seven Hundred Dollars (\$96,700) for FY 2024-25, and authorize the City Manager to execute  
37 relating documents.

39 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION**  
40 **OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

42 **SECTION 1.** The Mayor and City Commission hereby authorize utilization of the City  
43 of Milton, FL - RFP #2017.10.014 agreement with ENCO Utility Services LLC in an as needed  
44 amount not to exceed Ninety-Six Thousand, Seven Hundred Dollars (\$96,700) for FY 2024-  
45 25, and authorize the City Manager to execute relating documents.

47 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its  
48 passage and adoption.
