RESOLUTION NO. 2025 -**

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, FINDING UNIQUE CIRCUMSTANCES EXIST TO AUTHORIZE THE PURCHASE FROM MOTOROLA SOLUTIONS, INC. OF FORTY-SEVEN (47) AVIGILON CAMERAS FOR THE DEPARTMENT OF PUBLIC WORKS (DPW) COMPLEX/CITY WATER PLANT FOR AN AMOUNT OF ONE HUNDRED, NINETY-TWO THOUSAND, FIVE HUNDRED AND SIXTY-ONE DOLLARS (\$192,561); AND PROVIDING FOR AN EFFECTIVE DATE.

15 **WHEREAS**, Chapter 23, Section 23-8 (5), *Unique Circumstances*, of the City of
16 Hallandale Beach Code of Ordinances provides an exception to the competitive bidding
17 requirement where the City Commission finds unique circumstances to establish that
18 competitive bidding is not in the best interest of the City; however, such purchases in excess
19 of \$50,000.00 shall require a formal, written contract approved by the City Commission; and

21 **WHEREAS**, on March 19, 2023, the City Commission adopted Resolution No. 2023-
22 032, citing unique circumstances to utilize the discount pricing from the Broward Sheriff's
23 Office Contract # RLI 19053 JLS with Motorola Solutions, Inc. for converting and maintaining
24 the citywide CCTV system to Motorola's Avigilon platform due to compatibility with the
25 Broward Sheriff's Office Real-Time Crime Center (RTCC); and

27 **WHEREAS**, under separate resolution coming before the City Commission on March
28 19, 2025, Staff is seeking approval for the originally planned Phase 1 of the Citywide Public
29 Safety Program expansion by purchasing an additional fourteen (14) multisensor public
30 safety cameras (each containing four cameras) and forty-eight (48) License Plate Recognition
31 cameras, which purchase will also include a five-year warranty covering parts and a one-year
32 warranty for labor, provided by Motorola Solutions, Inc., such cameras being fully compatible
33 with the existing system, which is integrated with the RTCC for One Million, Two Hundred,
34 Ninety-Five Thousand, Four Hundred and Forty Three Dollars (\$1,295,443); and
