3 A RESOLUTION OF THE MAYOR AND CITY
4 COMMISSION OF THE CITY OF HALLANDALE BEACH,
5 FLORIDA, APPOINTING COMMISSION MEMBERS AS
6 CITY REPRESENTATIVES TO THE BROWARD LEAGUE
7 OF CITIES, FLORIDA LEAGUE OF CITIES, AND THE
8 NATIONAL LEAGUE OF CITIES FOR THE 2017-2018
9 TERM; AND PROVIDING AN EFFECTIVE DATE.

11 WHEREAS, annually, the Mayor and City Commission appoint Officers/Directors,
12 Voting Delegates and/or Alternates to represent the City of Hallandale Beach at the
13 Broward League of Cities, Florida League of Cities and National League of Cities; and

15 WHEREAS, as a result of the November 8, 2016, General Election, it is necessary
16 for the City Commission to appoint new voting delegates for the Florida League of Cities,
17 and National League of Cities; and

19 WHEREAS, the Broward League of Cities designations will expire in May, 2017,
20 accordingly the Broward League of Cities has requested each municipality to add this item
21 to its Agenda for consideration and to submit their appointments in April, 2017; and

23 WHEREAS, the Broward League of Cities' by-laws require that the Mayor and
24 City Commission appoint a Director, an Alternate and a Second Alternate to the Board of
25 Directors; and

27 WHEREAS, the Florida League of Cities' by-laws require the appointment of a
28 voting delegate and an alternate to attend and vote at the annual business session; and

30 WHEREAS, the National League of Cities' by-laws require the appointment of a
31 voting delegate, and one (1) alternate, (if desired) to attend and vote at the annual
32 business meeting.

34 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
35 COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:


