4 A RESOLUTION OF THE MAYOR AND CITY
5 COMMISSION OF THE CITY OF HALLANDALE BEACH,
6 FLORIDA, AUTHORIZING THE UTILIZATION OF THE
7 MIAMI-DADE COUNTY CONTRACT NO. RFP-00188 D
8 FOR SECURITY GUARD SERVICES FOR MIAMI-DADE
9 WATER & SEWER DEPARTMENT TO ENTER INTO A
10 THREE (3) YEAR AGREEMENT FOR ARMED SECURITY
11 SERVICES FROM SECURITY ALLIANCE, LLC IN AN
12 AMOUNT NOT TO EXCEED FOUR HUNDRED FIFTY
13 EIGHT THOUSAND AND SEVEN HUNDRED AND
14 EIGHTEEN DOLLARS (\$458,718); AND PROVIDING AN
15 EFFECTIVE DATE.

17 **WHEREAS**, pursuant to Section 23-8(6) Bids and Contracts from other entities, the
18 City Manager is authorized to procure all supplies, materials, equipment and services
19 pursuant to competitive bids and formal contracts of other governmental units when the best
20 interests of the City of Hallandale Beach ("City") would be served, subject to the requirement
21 that any purchase in excess of \$50,000.00 requires City Commission approval; and

23 **WHEREAS**, Miami-Dade County's competitively bid RFP No. 00188 D for Security
24 Guard Services resulted in a contract between Security Alliance, LLC and Miami-Dade
25 County that commenced on September 17, 2017 for an initial three year term and was
26 renewed until August 31, 2026; and

28 **WHEREAS**, the Public Works Department (DPW) desires to continue fulfilling the
29 Department of Homeland Security's Water Infrastructure Protection Initiatives by extending
30 its current security guards services to secure the Public Works Compound that includes the
31 City's Water Plant facility; and

33 **WHEREAS**, the City also wishes to continue to utilize Security Alliance, LLC to provide
34 Armed Security Services in the lobby of City Hall and to staff the metal detector during
35 commission meetings; and
36

37 **WHEREAS**, Staff seeks to utilize the agreement between Security Alliance, LLC and
38 Miami-Dade County as the basis for a three (3) year agreement between the City and Security

39 Alliance, LLC in an amount not to exceed four hundred fifty eight thousand and seven hundred
40 and eighteen dollars (\$458,718); and

42 **WHEREAS**, Staff determined that the outside vendor hourly rate for an armed security
43 guard under this contract is \$30.63 an hour, which is less than the annual salary plus benefits
44 for a uniformed police officer, which is more cost-effective for the City; and
45

46 **WHEREAS**, the provision of Armed Security Services for the Public Works Compound
47 and the lobby of City Hall is in the interest of the City of Hallandale Beach, and Staff
48 recommends that the Mayor and City Commission authorize the utilization of Miami-Dade
49 County's Contract RFP No. 00188 D for Security Guard Services to enter into a three (3) year
50 agreement between the City and Security Alliance, LLC in an amount not to exceed four
51 hundred fifty eight thousand and seven hundred and eighteen dollars (\$458,718); and
52 authorize the City Manager to execute all related documents.

54 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
55 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

57 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.
58

59 **SECTION 2.** The Mayor and City Commission hereby authorize the utilization of
60 Miami-Dade County's Contract RFP No. 00188 D for Security Guard Services to enter into a
61 three (3) year agreement between the City and Security Alliance, LLC in an amount not to
62 exceed four hundred fifty eight thousand and seven hundred and eighteen dollars (\$458,718);
63 and authorize the City Manager to execute all related documents.

65 **SECTION 3.** This Resolution shall take effect immediately upon its passage and
66 adoption.
