I consider myself very lucky and honored that the children, grandchildren and great grandchildren of Rosa Lee Cooper, a pioneer of Hallandale Beah, consider me a part of their family. However, having grown up with white privilege, I cannot know some of the things they have endured in their lives. As a Jew, I have been called names and other verbal abuse, but I have never been pulled over for driving while Jewish. My Father never sat me down to tell me how to act if I get stopped by the police because I am Jewish and I never had that talk with my sons. When Karen and I applied for a mortgage to buy our house, I was not concerned that since we are Jewish and our house is in a predominantly Jewish neighborhood, the bank would not give us the mortgage, and many other challenges and indignities that people of color face their whole lives. While my brain realizes what they have had to endure, my heart cannot understand the toll those things can take.

Which brings me to Howard Bowe. Unfortunately, he is far from the only man of color that has been killed by Hallandale Beach police, but his killing is in the news right now, and I believe it can illustrate that there is a problem in our city. Let us assume that all the reasons that the police got a warrant to search Mr. Bowe's home remain the same, but we change two things about Mr. Bowe. We make him white instead of black and we put his house in Golden Isles instead of the northwest section of the city. With those two changes, I fervently believe that Howard Bowe would be alive today. If the color of your skin and the location of your house can increase or decrease the chances that you will be killed by police, then something is wrong. Whether the police violated the law or not during the raid is something I will leave to others, but as the Mayor of Atlanta said after the killing of Rayshard Brooks, "There are things the police can do, but they are not necessarily the things they should do."

It seems that there are many people, white people, in Hallandale Beach, who believe that there are problems in the police departments of Minneapolis, and Louisville and Buffalo and Fort Lauderdale and on and on, but in Hallandale Beach our police department is beyond reproach. A somewhat Pollyannaish way to look at it in my opinion. I agree that change is scary, especially when you have few interactions with the police, and all of them are positive. Like the phrase global warming, the phrase defund the police was poorly thought out. The more accurate phrase should be redefining the police. Police today are asked to do a variety of things that should have nothing to do with policing. Police should not have to take care of the homeless. Police should not have to be the ones deal with the mentally ill. Police should not be called to intervene in non-violent family disputes. These can all be handled less expensively and with more expertise with people whose whole training is in those areas. Police should not be wasting their time taking statements in fender benders. Commissioner Lima-Taub is sponsoring an excellent ordinance dealing with condominiums. After she addressed my concerns with the ordinance, I fully support it, but enforcement should be by forensic accountants and people who are experts in condominium law, not the police. That leaves the police free to spend all their time on dealing with crime. Robberies, assaults, and unfortunately sexual assaults and murder.

I am not looking to destroy the Hallandale Beach police department. I am looking to make it more responsive to the needs of the public in a kinder and gentler way. If we can come up with a way to handle all the things the police do now in a better and less expensive way and lowered the chance that a citizen regardless of skin color or ethnicity would be injured or killed by the police, why would we not al least examine it? I love this city and I want to do whatever I can to make it better. I think any and all ideas about improving the city should be discussed. Not just in policing, but in all areas. Discussion does not mean we must change. It means lets look at all the ideas for improving life in the city and adopt those that work best for Hallandale Beach.
