A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, JOINING THE AMERICAN JEWISH CONGRESS IN SUPPORTING THE PRESIDENT’S RECOGNITION OF JERUSALEM AS ISRAEL’S CAPITAL CITY AND COMMITMENT TO RELOCATE THE AMERICAN EMBASSY TO JERUSALEM; AND PROVIDING FOR AN EFFECTIVE DATE.

Staff Summary:

Background:

Mayor Cooper requested staff bring forward an item for Commission consideration joining the American Jewish Congress in support of recognition of Jerusalem as Israel's Capital City and commitment to relocate the American embassy to Jerusalem from Tel Aviv.

Since its inception, the American Jewish Congress has been engaged in a continuous fight for equal rights for all Americans regardless of race, religion or national ancestry.

By approving the attached Resolution, the Mayor and City Commission would join the American Jewish Congress in supporting official recognition of Jerusalem as Israel's capital and the commitment to relocate the US Embassy to Jerusalem.

Why Action is Necessary:

Pursuant to Article V, Section 5.01 of the City of Hallandale Beach Charter, a Resolution adopted by the Commission is an expression of the Commission on matters of official concern and opinion.

Proposed Action:
