ON 04/14/24, I RESPONDED TO 233 NE 14 AVE BUILDING #B IN REFERENCE TO A HALLANDALE BEACH GARBAGE TRUCK (BIG TRUCK #1), CRASHING INTO A STRUCTURAL CANOPY.

ONCE ON SCENE, I MET WITH CITY EMPLOYEE ABEL VILLANUEVA DRIVER, WHO STATED HE WAS ENTERING THE NORTH SIDE OF THE LOCATION FROM NE 14 AVE IN REVERSE. VILLANUEVA FURTHER STATED AS HE APPROACHED THE NORTH ENTRY / EXIT DOORS, THE RIGHT TOP CORNER OF THE GARBAGE TRUCK CRASHED INTO THE OVERHEAD CANOPY WHICH IS ATTACHED TO THE BUILDING. THE IMPACT CAUSED THE CANOPY TO COLLAPSE AND FALL TO THE GROUND. THE RIGHT TOP CORNER AND THE REAR BUMPER OF THE TRUCK SUSTAINED SERIOUS BODY DAMAGE. THE AREA AROUND THE COLLAPSED CANOPY WAS TAPPED OFF WITH YELLOW CRIME SCENE TAPE.

THE CITY STRUCTURAL BUILDING INSPECTOR, RAFAEL CONTRERAS RESPONDED TO THE LOCATION TO ASSESS IF THERE WERE ANY STRUCTURAL SAFETY ISSUES TO THE BUILDING. NO FURTHER INFORMATION AT THIS TIME.

WHILE ON SCENE, I TOOK OVER-ALL, MID-RANGE AND CLOSE-UP PHOTOS OF THE ABOVE MENTIONED DAMAGE AND THE DAMAGE SUSTAINED TO THE CITY GARBAGE TRUCK.

THE MEDIA CARD WAS PLACED IN THE EVIDENCE KEY SLOT AT POLICE HEADQUARTERS.

NO FURTHER ACTION WAS TAKEN.
