RESOLUTION NO. 2026 -

A RESOLUTION OF THE MAYOR AND CITY COMMISSION
OF THE CITY OF HALLANDALE BEACH, FLORIDA,
AUTHORIZING UTILIZATION OF THE OMNIA PARTNERS
CONTRACT WITH PLAYCORE WISCONSIN INC, DBA
GAMETIME TO PURCHASE REPLACEMENT OF
PLAYGROUND EQUIPMENT AND PLAYGROUND SURFACING
AT THE DR. MARTIN LUTHER KING, JR. PARK FOR A TOTAL
NOT TO EXCEED AMOUNT OF THREE HUNDRED, EIGHTY-
TWO THOUSAND, EIGHT HUNDRED, TWENTY-NINE DOLLARS
AND NINETY-ONE CENTS (\$382,829.91); AND PROVIDING
FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to the City of Hallandale Beach Code of Ordinances, Section 23-9, Award, (e), the City Manager may award procurements within the delegated spending authority, and all other procurements, except emergency procurements, require commission approval for award; and

WHEREAS, pursuant to the City of Hallandale Beach Code of Ordinances, Section 23-5 Competitive procurement required; Procurement Mechanisms, Subsection (3) Cooperative Purchasing, the City may procure goods or services through a variety of arrangements whereby two or more public entities have the opportunity to purchase from the same supplier or multiple suppliers using a single competitive procurement mechanism, and Subsection (4) Piggybacking, the City may procure goods or services from vendors who have been selected as a result of a competitive selection process by another governmental entity if the selection process utilized by the contracting entity was substantially similar to the requirements of the City, and the goods or services procured by the City are procured pursuant to the original contract scope and terms; and

WHEREAS, the playground equipment at Dr. Martin Luther King, Jr. Park requires replacement due to rusting and deteriorating; and

WHEREAS, Playcore Wisconsin Inc, dba GameTime has submitted a proposal to replace the playground equipment and playground surfacing for a total amount not to exceed amount of

39 Cents (\$382,829.91) utilizing its contract with cooperative OMNIA Partners Contract 2017001134;

46 Two Thousand, Eight Hundred, Twenty-Nine Dollars and Ninety-One Cents (\$382,829.91), and

58 Wisconsin Inc, dba GameTime to purchase replacement of playground equipment and
59 playground surfacing at the Dr. Martin Luther King, Jr. Park for a total not to exceed amount of
60 Three Hundred, Eighty-Two Thousand, Eight Hundred, Twenty-Nine Dollars and Ninety-One
61 Cents (\$382,829.91), and authorize the City Manager to execute relating documents.
