**RESOLUTION NO. 2024 -**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING UTILIZATION OF THE AGREEMENT WITH HD SUPPLY FACILITIES MAINTENANCE LTD RFP 22-07 CUSTODIAL SUPPLIES THROUGH OMNIA PARTNERS COOPERATIVE AGREEMENT FOR FY 2024-25 FOR CLEANING SUPPLIES, EQUIPMENT AND CUSTODIAL RELATED SUPPLIES, SERVICES, AND SOLUTIONS IN A NOT TO EXCEED AMOUNT OF SIXTY-SEVEN THOUSAND, AND TWO HUNDRED DOLLARS (\$67,200); AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements, (6) Bids and Contracts from Other entities, and Section 23-9 Cooperative Purchasing, the City Manager is authorized to procure all supplies, materials, equipment, and services from other governmental units, when the best interests of the City would be served subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval; and

**WHEREAS**, on September 29, 2022, the County of Fresno (California) Unified School District entered into an agreement with HD Supply Facilities Maintenance LTD f/k/a Home Depot Pro Institutional RFP 22-07 Custodial Supplies for cleaning supplies, equipment and custodial related supplies, services, and solutions (the "Agreement") through an Omnia Partners cooperative agreement; and

**WHEREAS**, Staff desires to utilize the Agreement to purchase various supplies for FY 2024-25 outlined in a cost proposal that includes, without limitation, planned and unplanned purchases of paper towels, facial tissues, wipers, dispensing equipment, seat covers, brooms and dust pans, can liners and restroom cleaners in a not to exceed amount of Sixty-Seven Thousand, and Two Hundred Dollars (\$67,200); and

**WHEREAS**, Staff recommends that the Mayor and City Commission find it in the public interest to authorize utilization of the County of Fresno (California) Unified School District agreement with HD Supply Facilities Maintenance LTD RFP 22-07 Custodial Supplies

39 through Omnia Partners cooperative agreement for FY 2024-25 for cleaning supplies,  
40 equipment and custodial related supplies, services, and solutions in a not to exceed amount

52 agreement for FY 2024-25 for cleaning supplies, equipment and custodial related supplies,  
53 services, and solutions in a not to exceed amount of Sixty-Seven Thousand, and Two  
54 Hundred Dollars (\$67,200), and authorize the City Manager to execute all related documents.

56 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its  
57 passage and adoption.
