- Alamanda Drive
- Sunset Drive
- Tamarind Drive
- Oleander Drive
- Hibiscus Drive
- Palm Drive
- Blue Heron Drive
- West Side of South Ocean Drive
- (From County Line to #2017 (7 poles))

At this time, the City of Hallandale Beach requests a non-binding “ballpark” estimate of the cost for this conversion in the area denoted. The City understands that this is an estimate and should only be used for preliminary decision making and not for detailed planning purposes. We further understand that there are a number of approaches to project implementation, subject to FPL approval, that could save money and that these could be offsets to project costs from the previously approved above ground hardening project.

In addition, please provide the City with the non-refundable engineering deposit cost to obtain a detailed and “binding” estimate for this conversion project.
