4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
6 AUTHORIZING UTILIZATION OF THE U.S. COMMUNITIES  
7 GOVERNMENT PURCHASING ALLIANCE COOPERATIVE  
8 CONTRACT #R-TC-17006 FOR THE PURCHASE OF  
9 GENERAL PRODUCTS FROM AMAZON SERVICES, LLC IN  
10 AN AMOUNT NOT TO EXCEED TWO HUNDRED SIXTY-FIVE  
11 THOUSAND, FIVE HUNDRED AND FIFTY DOLLARS  
12 (\$265,550) FOR FISCAL YEAR 2025-26; AND PROVIDING  
13 FOR AN EFFECTIVE DATE.

15 **WHEREAS**, pursuant to Section 23-9 of the City of Hallandale Beach ("City") Code,  
16 the City Manager shall have the authority to join with other units of government in cooperative  
17 purchasing plans or to purchase pursuant to formal written contracts or competitive bids of  
18 other governmental units, when the best interests of the City would be served, subject to the  
19 requirement that purchases in excess of \$50,000 require City Commission approval; and

21 **WHEREAS**, as a member of the U.S. Communities Government Purchasing Alliance,  
22 the City is able to participate and utilize competitively solicited contracts to obtain the best  
23 goods/services and pricing available in the market; and  
24

25 **WHEREAS**, authorized City staff receive an electronic log-in to utilize the Amazon  
26 contracted pricing to make purchases on-line, and some of the purchase requests by  
27 departments include, without limitation, electrical adapters, ethernet cables, laptop batteries,  
28 audio auxiliary cables, drop cover cord protectors, fiber optic cables and heavy-duty pad  
29 locks, planned and unplanned purchases for special event supplies, pool supplies such as  
30 pump replacement pieces, training materials, plumbing and electric supplies, programming  
31 supplies such as teen zone arts/crafts, teen zone garden rakes/shovels/seeds, office  
32 supplies, giveaways for internal green initiatives, recycling bins for offices, litter clean-up  
33 supplies such as pick sticks, garbage bags, gloves, and workshop supplies; and

35 **WHEREAS**, for FY 2025-26, the total expenditures requested by City departments for  
36 Amazon Services, LLC / Amazon Business On-Line Marketplace exceed the fifty thousand  
37 (\$50,000) dollar threshold; and

38           **WHEREAS**, the Mayor and City Commission find that it is in the best interest of the  
39 City of Hallandale Beach to authorize the utilization of the requested contract.

42           **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**  
43 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

45           **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

46  
47           **SECTION 2. City Manager Authorization.** The Mayor and City Commission hereby  
48 authorize the utilization of the U.S. Communities Government Purchasing Alliance Contract  
49 # R-TC-17006 with Amazon Services, LLC / Amazon Business On-Line Marketplace for the  
50 purchase of general products for an amount not to exceed Two Hundred Sixty-Five  
51 Thousand, Five Hundred and Fifty Dollars (\$265,550) as provided for in fiscal year 2025-2026  
52 budget, and authorize the City Manager to execute all related documents to effectuate the  
53 purchase.

55           **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its  
56 passage and adoption.
