WHEREAS, authorized City staff receive an electronic log-in to utilize the Amazon contracted pricing to make purchases on-line, and some of the purchase requests by departments include, without limitation, electrical adapters, ethernet cables, laptop batteries, audio auxiliary cables, drop cover cord protectors, fiber optic cables and heavy-duty pad locks, planned and unplanned purchases for special event supplies, pool supplies such as pump replacement pieces, training materials, plumbing and electric supplies, programming supplies such as teen zone arts/crafts, teen zone garden rakes/shovels/seeds, office supplies, giveaways for internal green initiatives, recycling bins for offices, litter clean-up supplies such as pick sticks, garbage bags, gloves, and workshop supplies; and

**WHEREAS**, for FY 2025-26, the total expenditures requested by City departments for Amazon Services, LLC / Amazon Business On-Line Marketplace exceed the fifty thousand (\$50,000) dollar threshold; and
