RESOLUTION NO. 2016 - 160

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA AUTHORIZING THE CITY MANAGER TO PURCHASE AUTO AND TRUCK PARTS, ACCESSORIES, SUPPLIES AND SERVICERS UTILIZING CONTRACT #031212-GPC IN AN AMOUNT NOT TO EXCEED EIGHTY THOUSAND (\$80,000.00) DOLLARS BETWEEN NAPA AND THE NJPA; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PURCHASE AS PROVIDED FOR IN FISCAL YEAR 2016-2017 BUDGET; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, pursuant to Chapter 23, Section 23-8 (6), Exception to Bid Requirements, and Section 23-9 Cooperative Purchasing, the City Manager is authorized to procure supplies, materials, equipment and services from other governmental units, when the best interests of the City would be served subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval; and

**WHEREAS**, the National Joint Powers Alliance (NJPA) is a public agency that serves as a national municipal contracting agency, and it has the authority to develop and offer cooperative purchasing services to its membership; and

**WHEREAS**, the City is a member organization, ID#65491, and is able to utilize NJPA cooperative purchasing contracts in order to provide cost savings and cost avoidances that would otherwise be impossible for a City of our size to realize; and

**WHEREAS**, as in the past, City Administration wishes to utilize NAPA and the NJPA Contract #031212-GPC for the primary purchase of equipment, auto and truck, accessories, supplies and services in the amount of eighty thousand (\$80,000.00) dollars; and

**WHEREAS**, the City Administration anticipates that this fiscal year #2016-2017 expenditure for equipment, auto and truck parts, accessories, supplies and services in the amount of eighty thousand (\$80,000.00) dollars; and

40           **WHEREAS**, the City Administration recommends that the Mayor and City  
41 Commission authorize the purchase of equipment, auto and truck, accessories, supplies  
42 and services in the amount of eighty thousand (\$80,000.00) dollars through the use of  
43 contract #031212-GPC as it is in the best interest of the City of Hallandale Beach and its  
44 residents.

46           **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**  
47 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

48           **Section 1. City Manager's Authorization.** The Mayor and City Commission  
49 hereby authorize the City Manager to purchase equipment, auto and truck parts,  
50 accessories, supplies and services utilizing Contract #031212-GPC between NAPA and  
51 the NJPA in an amount not to exceed eighty thousand (\$80,000.00) dollars as provided  
52 for in fiscal year 2016-2017 budget, and authorize the City Manager to execute all  
53 necessary documents to effectuate the purchase.

54           **Section 2. Effective Date:** This resolution shall be effective immediately upon  
55 its adoption.


