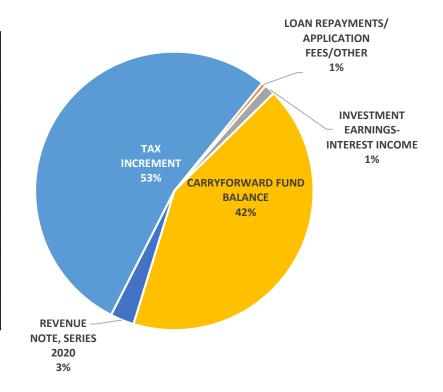

Taxable Value Snapshot

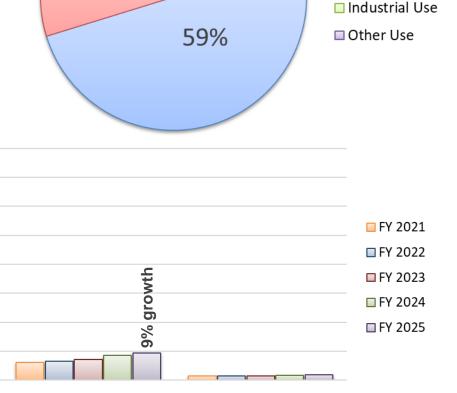

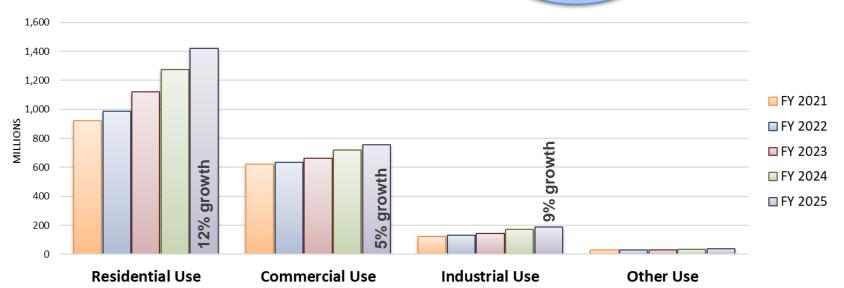

CRA Priorities for FY26



In FY 2026 the HBCRA wants to prioritize the following:

- Affordable housing Initiative
- CMAR projects
- Residential and commercial programs
- Wayfinding & Gateway Signage throughout the City

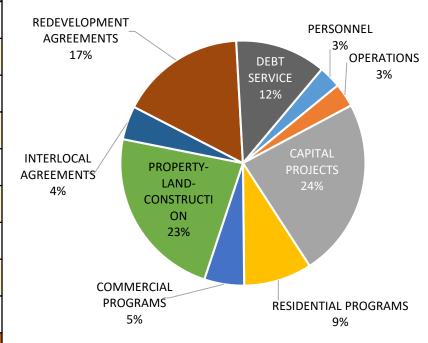
Approximately 14M has been set aside towards the purchase of properties, vacant lots, and renovation and construction of affordable units. This will aid in the affordable housing crisis as well as assist with the creation of a new affordable rental program that the HBCRA will be bringing forward in the upcoming fiscal year. The CRA's goal over the next 2 years is to construct or renovate at least 50 units of affordable housing.

Approximately 1.5M has been set aside for the continued development and beautification of District 8. Aiming to be the 'The Cultural Heart of Hallandale', District 8 will be a walkable outdoor gallery adorned with murals and unique architecture, engaging the community with street festivals and themed events.

Approximately 5.5M has been set aside for the creation of the highly anticipated Art Trail, which would extend the artistic flavor of Hallandale Beach throughout the city limits, encouraging visitors from all over to come explore our colorful city.
