21	allocation within the fiscal year budget. CPG applicants must be a registered 501(C)(3)
22	non-profit organization with the IRS; must have an active corporate status with the State

<u>2</u> 6	WHEREAS, the cycle for the Mini-Grants are approved on a yearly basis and
<u>-</u> 3 27	grants for greater than ten thousand (\$10,000) dollars have a grant cycle of three (3) years

30	WHEREAS, On April 25, 2017, the Notice of Grant Funding (NGF) for the
31	Community Partnership Program was released. In response to the NGF, the City received
32	twenty (20) proposals; and

34	WHEREAS, following oral presentations the Grants Committee scored each
35	proposer and recommends award of Five (5) Mini-Grants programs for a total of \$43,000

36	seven Grants Programs for a total of \$260,000; and one (1) HBCRA request was
37	recommended for funding for a total of \$35,000; and

39	WHEREAS, it is recommended that the City Commission approve the FY 2018
40	Community Partnership Grants and Mini-Grants to the recommended grantees as
41	identified in Table 2 of the cover memo for a total amount not to exceed three hundred
42	three thousand (\$303,000) dollars.
