RESOLUTION NO. 2017 – 99

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO REJECT THE ONE (1) RESPONSIBLE BID #FY 2016-2017-009 FROM C & W PIPELINE, INC. FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PUBLIC WORKS STORMWATER IMPROVEMENTS PROJECT; AUTHORIZING THE CITY MANAGER TO RE-ADVERTISE THE INVITATION TO BID; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on July 7th, 2017, the City of Hallandale Beach issued an Invitation to Bid #FY 2016-2017-000 for the Community Development Block Grant Public Works Stormwater Improvements Project; and

WHEREAS, a pre-bid meeting and site visit were held on July 25, 2017 and three (3) vendors attended the pre-bid meeting; and

WHEREAS, the City received one (1) bid response from C & W Pipeline, Inc. in the amount of \$244,629; and

WHEREAS, City staff reviewed the bid response submitted by C & W Pipeline, Inc. as well the opinion of probable cost submitted by Calvin, Giordano & Associates, Inc., the City's design consultant for this project; and

WHEREAS, the bid price submitted by C & W Pipeline is \$78,740 higher than the opinion of probable cost of \$165,889, and \$32,917 higher than the total budget amount allocated to this project of \$211,712; and

WHEREAS, pursuant to Section 23-12 of the City of Hallandale Beach Code, the City Commission may authorize City Manager to a) reject all bids; or b) reject all bids and re-advertise, pursuant to the procedure prescribed in the City Code; and

WHEREAS, it is in the best interest of the City for the Mayor and City Commission to authorize the City Manager to reject the bid response from C & W Pipeline, Inc. and re-

38 advertise Invitation to Bid #FY 2016-2017-000 to receive an adequate amount of
39 responsive, responsible bidders.

41 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**
42 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

44 **SECTION 1.** The foregoing "Whereas" clauses are hereby incorporated herein.

46 **SECTION 2.** The Mayor and City Commission hereby authorize the City Manager
47 to reject the one (1) responsible bid #FY 2016-2017-000 from C & W Pipeline, Inc. for the
48 Community Development Block Grant Public Works Stormwater Improvements Project,
49 and authorize the City Manager to re-advertise Invitation to Bid #FY 2016-2017-000 to
50 receive an adequate amount of responsive, responsible bidders.

52 **SECTION 3.** This Resolution shall take effect immediately upon its passage and
53 adoption.
