RESOLUTION NO. 2016 - 117

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A WORK AUTHORIZATION TO SYNALOVSKI ROMANICK SAYE, LLC PURSUANT TO CONTINUING SERVICES AGREEMENTS AWARDED THROUGH RFP FY#2013-2014-006 FOR THE DESIGN, PERMIT AND PLANS FOR THE INGALLS PARK PROJECT FOR A TOTAL COST NOT TO EXCEED ONE HUNDRED EIGHTY SIX THOUSAND (\$186,000.00) DOLLARS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, with the passage of the November 4, 2014, Parks GO Bond 2020, the Office of Capital Improvements is moving forward with the implementation of the City Wide Park Master Plan; and

WHEREAS, Ingalls Park is the next Park to be built through the General Obligation Bond; and

WHEREAS, the development will be constructed according to the City-wide Master Plan prepared by Bermello Ajamil & Partners, Inc.; and

WHEREAS, the City-wide Parks Master Plan proposes minimal changes to Ingalls Park, stating that the present park layout and venues are in consonance with the community needs and desires; and

WHEREAS, as per Florida Statute 287.055, if an agency project has an estimated construction cost of less than \$2 million, or the study/design services is less than \$200,000, an agency may utilize the services of a consultant through a Continuing Services Contract; and

WHEREAS, Synalovski Romanick Saye, LLC is listed as the next available firm on the City's continuing services contract rotation list; and

WHEREAS, the City Administration requests the Mayor and City Commission authorize the City Manager to issue a work authorization to Synalovski Romanick Saye, LLC to design, permit and provide plans for the Ingalls Park project in an amount not to exceed one hundred eighty six thousand (\$186,000.00) dollars; and

41 **WHEREAS**, the Mayor and City Commission have determined that it is in the best interest
42 of the City and its residents to authorize the City Manager to issue a work authorization to
43 Synalovski Romanick Saye, LLC to design, permit and provide plans for the Ingalls Park project
44 in an amount not to exceed one hundred eighty six thousand (\$186,000.00) dollars and to
45 authorize the City Manager to execute an agreement as attached as Exhibit "C".

47 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
48 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

50 **SECTION 1. City Manager's Authorization.** The Mayor and City Commission hereby
51 authorize the City Manager to issue a work authorization to Synalovski Romanick Saye, LLC to
52 design, permit and provide plans for the Ingalls Park project in an amount not to exceed one
53 hundred eighty six thousand (\$186,000.00) dollars. Further authorizing the City Manager to
54 execute an agreement in substantially the same form as attached as Exhibit "C" and to take
55 necessary action to effectuate the project.

57 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its
58 passage and adoption.

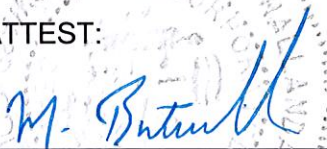
