11 12	WHEREAS, in 2007 the City entered into a maintenance agreement with the
13	Town of Pembroke Park and the Florida Department of Transportation to provide for
14	the maintenance and operational services of the South Broward Pumping Station
15	located along the west side of I-95 in Pembroke Park; and
16	
17	WHEREAS, the station, including all components of the gravity pipe from
18	Chaves Lake to the pump station and the pressure pipe from the pump station to its
19	outfall location, is owned by the State of Florida Department of Transportation
20	("Department"). ; and
21	
22	WHEREAS, the station is an essential infrastructure component that prevents
23	flooding along Pembroke Rd and I-95 for both communities. Thus, in accordance with
24	the 2007 Agreement, the City and the Town have shared use and maintenance
25	responsibilities; and
26	
27	WHEREAS, the 2007 Agreement provided that, for unforeseen expenditures,
28	the parties would meet to attempt to mutually agree upon the amount and distribution
29	of the additional funding needed; and

31	WHEREAS, the 2007 Agreement expired in 2011; however, the City and the
32	Town have continued to work in good faith to ensure the Station's functionality and
33	operation in an effort serve the interests of their respective communities; and

35	WHEREAS, the Station's diesel tank began to leak, creating an environmental
36	hazard and the Station sustained substantial electrical damage due to a suspected
37	lightning strike, rendering it non-functional; and
38	
39	WHEREAS, Staff recommends that the City Commission approve the
40	proposed cost-sharing agreement incorporated herein as Exhibit "A," to facilitate
41	advancement of the project and authorize the City to proceed with the emergency
42	repairs of station in advance of the imminent rainy season.
43	
44	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY
45	COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
46	
47	SECTION 1. The foregoing "Whereas" clauses are incorporated herein.
48	
49	SECTION 2. The Mayor and City Commission hereby authorize execution of
50	the Agreement with the Town of Pembroke Park attached as Exhibit "A", together with
51	such changes as may be subsequently agreed to by the City and Town, and approved
52	as to form and legal sufficiency by the City Attorney, and authorize the City Manager
53	to proceed with emergency repairs to restore the station to an operational status.

55	SECTION 3. This Resolution shall take effect immediately upon its passage
56	and adoption.
