RESOLUTION NO. 2021-

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO AWARD BID # FY 2020-2021-001, 45TH YEAR CDBG PUBLIC WORKS IMPROVEMENTS PROJECT, TO KAILAS CORP. IN THE AMOUNT NOT-TO-EXCEED ONE HUNDRED SIXTY FIVE THOUSAND AND SIXTEEN DOLLARS (\$165,016) DOLLARS, INCLUSIVE OF A TEN PERCENT (10%) CONTINGENCY FOR UNFORESEEN CIRCUMSTANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PROJECT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Community Development Block Grant (CDBG) program, run by the U.S. Department of Housing and Urban Development, is a flexible program that provides communities with resources to address a wide range of community development needs; and

WHEREAS, cities participating in the Broward County CDBG program receive an allocation based on a Department of Housing and Urban Development (HUD) funding formula; and

WHEREAS, the formula generally takes into consideration community housing conditions, population and poverty indicators; and

WHEREAS, on April 3, 2019, the City Commission adopted Resolution No. 2019-026 authorizing the submittal of the 45th Year Community Development Block Grant Application Package, including one project for the Public Works Department and one for the Human Services Department; and

WHEREAS, on August 6, 2019, the City received a funding award letter from Broward County awarding the City for the Public Works Improvements Project submitted by the Public Works Department; and

40 **WHEREAS**, the 45th Year CDBG Public Works Improvement Project involves
41 public works and utility infrastructure improvements including drainage improvements,
42 sidewalks, regrading and sodding located at the intersection of NW 7th Avenue and NW
43 3rd Court (Exhibit 3 Location); and

45 **WHEREAS**, on November 18, 2020, a mandatory pre-bid meeting was held and
46 eight (8) vendors attended. The Bid was due on December 14, 2020 and a total of eight
47 (8) vendors responded to the solicitation. Staff evaluated the responses and determined
48 Kailas Corp. to be the lowest responsible and responsive Bidder; and

50 **WHEREAS**, the City Administration recommends that the City award Bid #FY
51 2020-2021-001, 45th Year CDBG Public Works Improvements Project, to Kailas Corp. in
52 the amount not-to-exceed one hundred sixty five thousand and sixteen dollars
53 (\$165,016), inclusive of a ten percent (10%) contingency for unforeseen circumstances.

55 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**
56 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

57 **SECTION 1.** The above clauses are incorporated in full in this Resolution.

60 **SECTION 2. City Manager's Authorization.** The Mayor and City Commission
61 hereby authorize the City Manager to award Bid #FY 2020-2021-001, 45th Year CDBG
62 Public Works Improvements Project to Kailas Corp., Inc. in the amount not-to-exceed
63 one hundred sixty five thousand and sixteen dollars (\$165,016), inclusive of a ten
64 percent (10%) contingency for unforeseen circumstances. The City Manager is
65 authorized to execute all necessary documents to effectuate the project.

67 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon
68 its passage and adoption.
