RESOLUTION NO. 2018-**

**A RESOLUTION OF THE MAYOR AND CITY
COMMISSION OF THE CITY OF HALLANDALE BEACH,
FLORIDA, AUTHORIZING THE PURCHASE OF THE TI
TRAINING SIMULATOR AT A COST NOT TO EXCEED
EIGHTY TWO THOUSAND THREE HUNDRED AND FIVE
DOLLARS (\$82,305) PURSUANT TO THE
COMPETITIVELY OBTAINED CONTRACT OF MIAMI-
DADE COUNTY; AND PROVIDING FOR AN EFFECTIVE
DATE.**

14 **WHEREAS**, pursuant to Section 23-8(6) Bids and Contracts from other entities,
15 the City Manager is authorized to procure all supplies, materials, equipment and services
16 pursuant to competitive bids and formal contracts of other governmental units when the
17 best interests of the City would be served, subject to the requirement that any purchase
18 in excess of \$50,000.00 requires City Commission approval; and

19
20 **WHEREAS**, the Hallandale Beach Police Department (HBPD) has a strong
21 commitment to developing the skills and abilities of all its law enforcement officers through
22 a comprehensive training curriculum. Over the past year, the department has invested in
23 the training unit by adding a police sergeant and increasing the amount of training hours
24 an officer must undergo per year; and

25
26 **WHEREAS**, part of that commitment is the repurposing of a room to be utilized for
27 training. This training room, which has already been constructed, is now ready to house
28 the training simulator and be outfitted with mats and equipment for defensive tactics
29 training.

30
31 **WHEREAS**, based on the direction provided by the City Commission on
32 September 12, 2016, the Police Department began to research numerous scenario based
33 firearms simulators while completing the construction of the training room.

36 **WHEREAS**, after consulting with surrounding agencies and reviewing the product
37 from various vendors, it became evident the Training Lab Use of Force Training Simulator
38 from Ti Training Corporation is the best product for our agency. The system utilizes the
39 latest advancements in video, laser, radio frequency and programming technology to
40 provide an intuitive, easy to maintain training tool to aid in teaching public safety personnel
41 how to effectively and safely perform their duties. The course begins with classroom theory
42 and progresses to “hands on” proficiency based exercises; and

43
44 **WHEREAS**, the Ti Training Simulator is currently being utilized by the Broward
45 Community College Institute of Public Safety. This college is where we send our police
46 recruits and also where we train our sworn officers utilizing this system. Our trainers are
47 proficient with its operations and functionality; and

48
49 **WHEREAS**, Miami Dade County procured the Ti Training Simulator in 2017 via
50 competitive solicitation and awarded contract # EPPRFP-00485. The contract remains
51 valid, and staff is requesting to piggyback this contract; and

52
53 **WHEREAS**, the Mayor and City Commission have determined that it is in the best
54 interest of the City and its residents to purchase the Ti Training Simulator at a cost not to
55 exceed eighty two thousand three hundred and five dollars (\$82,305) pursuant to the
56 terms and conditions as specified in the competitively obtained contract of Miami-Dade
57 County.

59 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**
60 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

61 **SECTION 1.** The foregoing “Whereas” clauses are incorporated herein.

64 **SECTION 2.** The Mayor and City Commission hereby authorize the City Manager
65 to purchase the Ti Training Simulator at a cost not to exceed eighty two thousand three
66 hundred and five dollars (\$82,305) pursuant to the terms and conditions as specified in
67 the competitively obtained contract of Miami-Dade County and to execute all agreements
68 necessary to effectuate the purchase.

70 **SECTION 4. Effective Date.** This Resolution shall become effective immediately
71 upon its adoption.
