20	official's duties, as evidenced the charges of violations of the Florida Public Official's Code o

23	WHEREAS, the Commission finds that the matter stems from conduct occurring while		
24	Commissioner Lazarow carried out her public duties and served a public purpose in filing required		
25	disclosure forms; and

27	WHEREAS, Commissioner Lazarow prevailed against the allegations upon the		
28	Commission on Ethic's determination that they would not proceed with any hearing on the matter		
29	and

31	WHEREAS, Florida common law affords public officials the right to legal representation at		
32	public expense against matters arising out of the performance of their public duties and while		
33	serving a public purpose.
