4 A RESOLUTION OF THE MAYOR AND CITY  
5 COMMISSION OF THE CITY OF HALLANDALE BEACH,  
6 FLORIDA, ADOPTING THE CITY OF HALLANDALE  
7 BEACH COMPREHENSIVE EMERGENCY MANAGEMENT  
8 PLAN; AND PROVIDING AN EFFECTIVE DATE.

10 WHEREAS, the City of Hallandale Beach shares a responsibility with both  
11 Broward County and the State of Florida to be prepared in the event of a natural,  
12 technological, or man-made emergency or disaster that threatens life, property, or the  
13 environment. Florida State Statute 252.38 (2) "authorizes and encourages the City of  
14 Hallandale Beach to create a municipal emergency management program"; and  
15

16 WHEREAS, in order to provide for an effective response to emergency  
17 situations, the City must create an emergency management program and  
18 comprehensive emergency plan that complies with all the standards and requirements  
19 applicable to County Comprehensive Emergency Management Plan. Furthermore, the  
20 approved plan must be adopted by resolution of the governing body of the jurisdiction in  
21 accordance with 27P-6.010(8), F.A.C.; and

23 WHEREAS, the comprehensive plan attached as Exhibit A is in accordance with  
24 existing federal and state statutes, and in coordination with the National Response  
25 Framework. This plan is written and will be updated in compliance with the Federal  
26 Emergency Management Agency's Developing and Maintaining Emergency Operations  
27 Plan, Comprehensive Preparedness Guide 101, Version 2.0, November 2010.

30 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY  
31 COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

33 SECTION 1. The foregoing "Whereas" clauses are incorporated herein.

**SECTION 2.** The Mayor and City Commission of the City of Hallandale Beach,  
hereby approve and adopt the City of Hallandale Beach Comprehensive Emergency  
Management Plan, attached as Exhibit A.

**SECTION 3.** This document replaces and supersedes all previous versions of  
the Comprehensive Emergency Operations Plan.

**SECTION 4.** This resolution shall become effective immediately upon adoption.
