**RESOLUTION NO. 2022 - 118**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE UTILIZATION OF THE GSA CONTRACT 47QTCA20D00B5 WITH VERIZON FOR THE PURCHASE OF CELLULAR AND WIRELESS SERVICES AND DEVICES FOR ALL CITY DEPARTMENTS FOR AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000) DOLLARS PER FISCAL YEAR; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Chapter 23, Section 23-8 (6), Exception to Bid Requirements, and Section 23-9 Cooperative Purchase, the City Manager is authorized to procure supplies, materials, equipment and services from contracts of other governmental units, when the best interests of the City would be served subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval; and

**WHEREAS**, the Florida Department of Management Services (DMS) provides contracts available to all government agencies with the best terms and rates for public agencies, and the General Services Administration (GSA) leverages the purchasing power of the Federal Government to offer the best terms and rates for agencies at the Federal/State/Local Level; and

**WHEREAS**, the use of the negotiated contracts allows state and local governments to use GSA schedules for select purchases under multiple authorized programs, and the utilization of GSA schedules to obtain equipment and services, thereby saving taxpayers money; and

**WHEREAS**, Verizon wireless provides cellular and wireless internet services vital to city staff including the Hallandale Beach Police Department; and

**WHEREAS**, the Information and Technology (IT) Department manages cellular and wireless internet devices citywide acting as the central department in charge of management the equipment and service. The IT Department also manages the City's cellular and wireless communications for all City Departments; and

40           **WHEREAS**, GSA Contract 47QTCA20D00B5 covers contract period from June  
41 11, 2020 to June 10, 2025; and

43           **WHEREAS**, cellular services are provided on a month-to-month basis, as utilized,  
44 and a written agreement, other than a purchase order, is not in the best interest of the  
45 City; and

47           **WHEREAS**, the City Administration has identified a need to utilize the GSA  
48 Contract 47QTCA20D00B5 to purchase from Verizon cellular and wireless internet  
49 services for an amount not to exceed one hundred twenty thousand (\$120,000) dollars  
50 per fiscal year; and

53           **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**  
54 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

56           **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.


58           **SECTION 2.** The Mayor and City Commission hereby authorize the City  
59 Manager to utilize the GSA Contract 47QTCA20D00B5 to purchase from Verizon cellular  
60 and wireless internet services and devices for an amount not to exceed one hundred  
61 twenty thousand (\$120,000) dollars per fiscal year through the duration of the above  
62 named GSA Contract; waives any requirement for additional written agreement given the  
63 month-to-month nature of the service; and further authorizing the City Manager to execute  
64 all related documents to effectuate the purchases.

66           **SECTION 3. Effective Date.** This Resolution shall take effect  
67 immediately upon its passage and adoption.
