A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING A CCNA WORK AUTHORIZATION WITH R. J BEHAR & COMPANY TO DESIGN DRAINAGE IMPROVEMENTS FOR THE DEPARTMENT OF PUBLIC WORKS COMPOUND AS SET FORTH IN ITS COST PROPOSAL IN AN AMOUNT NOT TO EXCEED ONE HUNDRED FIFTY-SIX THOUSAND, THREE HUNDRED TWENTY-SIX DOLLARS AND EIGHTY-THREE CENTS (\$156,326.83); AUTHORIZING THE CITY MANAGER TO SIGN ALL RELATED DOCUMENTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 23, Section 23-4, City of Hallandale Beach Code of Ordinances, purchases of and contracts for equipment, supplies, and contractual services, when the estimated cost shall exceed \$50,000.00, except as specifically provided in that section, shall be based, wherever possible, on competitive bids Code of Ordinances, Code of Ordinances; and

WHEREAS, on August 5, 2020, the City Commission of Hallandale Beach adopted Resolution 2020-054 authorizing continuing service agreements solicited through RFP #2018-2019-012 – Continuing Professional Architectural and Engineering Services pursuant to Section 287.055, F.S., the Consultants Competitive Negotiation Act (CCNA); and

WHEREAS, the capacity of the current stormwater system is inadequate to manage the drainage of the Department of Public Works (DPW) compound in a manner that will allow for a safe operational area during heavy flooding events; and

WHEREAS, Staff seeks to improve the drainage system at its DPW compound, and R. J Behar & Company submitted a cost proposal to complete the design for such drainage improvements in an amount not to exceed One Hundred Fifty-Six Thousand, Three Hundred Twenty-Six Dollars and Eighty-Three Cents (\$156,326.83); and
