14 15	WHEREAS, pursuant to Code of Ordinances, Chapter 23, Section 23-8(6) Bids and
16	Contracts from other entities, the City Manager is authorized to procure all supplies,
17	materials, equipment, and services pursuant to competitive bids and formal contracts of
18	other governmental units when the best interests of the City would be served, subject to the
19	requirement that any purchase in excess of \$50,000 requires City Commission approval;

22	WHEREAS, the Department of Sustainable Development's Planning and Zoning
23	Division has been experiencing a staff shortage due to challenges filling the three current
24	vacancies that have proven difficult to fill: Principal Planner, Senior Transportation Planner,
25	and Associate Planner; and
26 27	WHEREAS, in July of 2023, the City of Hallandale Beach utilized the City of
28	Kissimmee's RFQ #2021-001 for Continuing Services for Professional Planning Consulting
29	agreement for professional planning consultant services though Inspire Placemaking
30	Collective, Inc. (Inspire), in a not to exceed amount of Twenty-Five Thousand Dollars
31	(\$25,000); and
32	
33	WHEREAS, the Kissimmee agreement had been awarded to S&ME Inc., which later
34	transferred the awarded contract to Inspire through an Assignment and Assumption
35	Agreement approved by the City of Kissimmee; and

WHEREAS, the services will be utilized as needed and paid through salary savings
from vacant positions, but are estimated not to exceed Two Hundred Thousand Dollars
(\$200,000) annually; and

41 WHEREAS, due to continuing shortages, Staff recommends that the Mayor and City 42 Commission authorize utilization of the services of Inspire Placemaking Collective, Inc. 43 (Inspire) through the City of Kissimmee's RFQ #2021-001 for Continuing Services for 44 Professional Planning Consulting agreement for a one year period commencing in July 45 2023 in an amount of Two Hundred Thousand Dollars (\$200,000), with an option to do 46 annual extensions subject to extensions by the City of Kissimmee, and authorize the City 47 Manager to execute all relating documents.

(Inspire) (also known as S&ME, Inc.), utilizing the City 56 of Kissimmee's RFQ #2021-001, for Continuing Services for Professional Planning 57 Consulting agreement for a one year period commencing in July 2023 in an amount of Two 58 Hundred Thousand Dollars (\$200,000), with an option to do annual extensions, not to 59 exceed Two Hundred Thousand Dollars (\$200,000) annually, subject to extensions by the 60 City of Kissimmee, and authorize the City Manager to execute all relating documents.
