RESOLUTION NO. 2023 - 065

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDING RFP NO. FY 2022-2023-009 - ROADWAY RESTORATION AND REPAIR TO WEEKLEY ASPHALT PAVING, INC., THE ONLY RESPONSIVE BIDDER, IN A NOT TO EXCEED AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000); AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO NEGOTIATE THE UNIT COSTS PROPOSED IN THE RESPONSE TO THE RFP AND TO EXECUTE ALL RELATED DOCUMENTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Code of Ordinances, Chapter 23, Section 23-4, all purchases of and contracts for equipment, supplies, and contractual services, when the estimated cost shall exceed \$50,000.00, shall be based, wherever possible, on competitive bids, and pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager shall have the authority to recommend to the City Commission award of contracts; and

WHEREAS, poor weather conditions and frequent traffic continuously create potholes, cracks, sinkholes, and unstable road conditions within the City; and

WHEREAS, on May 1, 2023, the City released RFP No. FY 2022-2023-009 - Roadway Restoration and Repair; and

WHEREAS, Staff recommends that the Mayor and City Commission award RFP No. FY 2022-2023-009 - Roadway Restoration and Repair to Weekley Asphalt Paving, Inc., the only responsive bidder, in a not to exceed amount of Five Hundred Thousand Dollars (\$500,000); and authorize the City Manager or his designee to negotiate the unit costs proposed in the response to the RFP and other relevant terms in an agreement for Roadway Restoration.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:
