8 THROUGH THE CITY OF CHARLOTTE, N.C. RFP NO. 269-2018-
9 047 FOR LEASING SANITATION TRUCKS FROM BIG TRUCK
10 RENTAL, LLC, FOR AN AMOUNT NOT TO EXCEED THREE
11 HUNDRED AND SEVENTEEN THOUSAND DOLLARS (\$317,000)
12 FOR FY 2021-2022; AND PROVIDING AN EFFECTIVE DATE.

15 **WHEREAS**, pursuant to Section 23-8(6) Bids and Contracts from other
16 entities, the City Manager is authorized to procure all supplies, materials,
17 equipment, and services pursuant to competitive bids and formal contracts of other
18 governmental units when the best interests of the City would be served, subject to
19 the requirement that any purchase in excess of \$50,000.00 requires City
20 Commission approval; and

21 **WHEREAS**, for Fiscal Year 2020-2021 the City Commission approved
22 Resolution No. 2021-029 to utilize Big Truck Rental to procure front load sanitation
23 truck to service the solid waste collection needs of Commercial and Multi-Family
24 accounts; and

25 **WHEREAS**, the City is currently leasing three (3) rental front loader refuse
26 trucks (diesel) from Big Truck Rental, LLC, namely two (2) 2020 Peterbilt Front
27 Loader trucks and one (1) 2021 Mack Front Loader truck, and seeks to continue
28 leasing them during FY 2021-22; and

29 **WHEREAS**, pending release of the RFP to outsource the Multi-Family and
30 Commercial Solid Waste Collection operation, leasing the trucks (rather than
31 purchasing them) is the most cost beneficial course of action to keep providing the
32 core service of trash removal, and therefore is in the public interest.

33 **WHEREAS**, Staff seeks approval to utilize the competitively solicited
34 OMNIA PARTNERS contract #2019-000319 with Big Truck Rental, LLC Inc.
35 through the City of Charlotte, North Carolina's RFP No. 269-2018-047 for the rental

of the trucks during FY 2021-22 in an amount not to exceed Three Hundred and Seventeen Thousand Dollars (\$317,000).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

SECTION 1. The foregoing "Whereas" clauses are incorporated herein.

SECTION 2. The Mayor and City Commission hereby authorize utilization the competitively solicited OMNIA PARTNERS contract #2019-000319 with Big Truck Rental, LLC Inc. through the City of Charlotte, North Carolina's RFP No. 269-2018-047 for the rental of trucks for an amount not-to-exceed Three Hundred and Seventeen Thousand Dollars (\$317,000); and authorize the City Manager to execute all relating documents.

SECTION 3. Effective Date. This Resolution shall take effect immediately upon its passage and adoption.
