WHEREAS, for Fiscal Year 2020-2021 the City Commission approved Resolution No. 2021-029 to utilize Big Truck Rental to procure front load sanitation truck to service the solid waste collection needs of Commercial and Multi-Family accounts; and

WHEREAS, the City is currently leasing three (3) rental front loader refuse trucks (diesel) from Big Truck Rental, LLC, namely two (2) 2020 Peterbilt Front Loader trucks and one (1) 2021 Mack Front Loader truck, and seeks to continue leasing them during FY 2021-22; and

WHEREAS, pending release of the RFP to outsource the Multi-Family and Commercial Solid Waste Collection operation, leasing the trucks (rather than purchasing them) is the most cost beneficial course of action to keep providing the core service of trash removal, and therefore is in the public interest.

WHEREAS, Staff seeks approval to utilize the competitively solicited OMNIA PARTNERS contract #2019-000319 with Big Truck Rental, LLC Inc. through the City of Charlotte, North Carolina's RFP No. 269-2018-047 for the rental
