4 **A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF**
5 **THE CITY OF HALLANDALE BEACH, FLORIDA,**
6 **AUTHORIZING THE CITY MANAGER TO PROCURE**
7 **INSPECTION AND BUILDING PLAN REVIEW SERVICES ON**
8 **AN AS NEEDED BASIS FROM CALVIN, GIORDANO &**
9 **ASSOCIATES, INC., C.A.P. GOVERNMENT, INC. AND**
10 **BUREAU VERITAS PURSUANT TO RFQ #2017-08 FROM THE**
11 **CITY OF PARKLAND IN AN AMOUNT NOT TO EXCEED FOUR**
12 **HUNDRED THOUSAND DOLLARS (\$400,000) FOR FISCAL**
13 **YEAR 2017-18; AUTHORIZING THE CITY MANAGER TO**
14 **EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE**
15 **THE PROCUREMENT OF SERVICES; AND PROVIDING FOR**
16 **AN EFFECTIVE DATE.**

17 **WHEREAS**, pursuant to Section 23-8(6) Bids and Contracts from other entities, the
18 City Manager is authorized to procure all supplies, materials, equipment and services
19 pursuant to competitive bids and formal contracts of other governmental units when the best
20 interests of the City would be served, subject to the requirement that any purchase in excess
21 of \$50,000.00 requires City Commission approval; and

23 **WHEREAS**, on February 15, 2017, the City of Parkland awarded RFQ #2017-08 to
24 Calvin, Giordano & Associates, Inc., C.A.P. Government, Inc., and Bureau Veritas for
25 inspection and building plan review services on an as needed basis for a three (3) year term
26 with one successive two (2) year renewal option; and

28 **WHEREAS**, during the first two quarters of fiscal year 2017/18, the amount of permit
29 applications submitted to the City increased by more than 14% over applications submitted
30 during the same time period in fiscal year 2016/17. The increased activity has created the
31 need for additional technical personnel to maintain an acceptable level of service; and

33 **WHEREAS**, the City Administration has determined it is in the best interest of the City
34 of Hallandale Beach to utilize the City of Parkland contracts with Calvin, Giordano &
35 Associates, Inc., C.A.P. Government, Inc., and Bureau Veritas pursuant to RFQ #2017-08, as
36 may be further amended, to procure inspection and building plan review services in an amount
37 not to exceed four hundred thousand dollars (\$400,000) for fiscal year 2017-18.

39 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION
40 OF THE CITY OF HALLANDALE BEACH, FLORIDA:

41 SECTION 1. The foregoing "Whereas" clauses are incorporated herein.

43 SECTION 2. City Manager Authorization. The Mayor and City Commission hereby
44 authorize the City Manager to execute contracts for building plan review and inspection services
45 on an as needed basis from Calvin Giordano & Associates, Inc., C.A.P. Government, Inc., and
46 Bureau Veritas for a three (3) year term with one successive two (2) year renewal option
47 pursuant to RFQ #2017-08 from the City of Parkland, as may be further amended, in an amount
48 not to exceed four hundred thousand dollars (\$400,000) for fiscal year 2017-18, and the
49 budgeted amounts in future fiscal years. The City Manager is authorized to take all necessary
50 actions to implement the project as provided for in the fiscal year 2017-18 budget.

52 SECTION 3. Effective Date. This resolution shall be effective immediately upon its
53 adoption.


