4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
6 AUTHORIZING THE UTILIZATION OF THE OMNIA  
7 PARTNERS CONTRACT #192163-WWG WITH W. W.  
8 GRAINGER, INC. FOR SUPPLIES, INDUSTRIAL EQUIPMENT  
9 AND TOOLS FOR AN AMOUNT NOT TO EXCEED ONE  
10 HUNDRED FIVE THOUSAND FIVE HUNDRED (\$105,500.00)  
11 DOLLARS; AND PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, Pursuant to Chapter 23, Section 23-8 (6), Exception to Bid Requirements,  
15 and Section 23-9 Cooperative Purchasing, the City Manager is authorized to procure  
16 supplies, materials, equipment and services from other entities, when the best interests of  
17 the City would be served subject to the requirement that any purchase in excess of \$50,000  
18 requires City Commission approval; and

20 **WHEREAS**, the City actively participates in co-ops in order to provide cost savings  
21 and cost avoidances; and

23 **WHEREAS**, OMNIA Partners is the largest and most trusted cooperative purchasing  
24 organization for public sector procurement. OMNIA Partners have brought together the  
25 nation's two leading cooperative purchasing organizations – National IPA and U.S.  
26 Communities – under one roof to form OMNIA Partners Public Sector; and

28 **WHEREAS**, the City seeks to participate in OMNIA Partners Contract Number 192163  
29 with W.W. Grainger, Inc. for maintenance, repairs and operations supplies, industrial  
30 equipment and tools; and

33 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**  
34 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

36 **SECTION 1. City Manager Authorization.** The Mayor and City Commission  
37 hereby authorize the utilization of OMNIA Partners Contract #192163 with W.W. Grainger for  
38 the purchase of supplies, industrial equipment and tools, for facility maintenance, repairs and

operations for an amount not to exceed one hundred five thousand five hundred (\$105,500.00) dollars as provided for in the fiscal year 2023-2024 budget and authorize the City Manager to execute all related documents to effectuate the purchase.

**SECTION 2. Effective Date.** This Resolution shall take effect immediately upon its passage and adoption.
