b. Proposal to amend City Ordinance #2020-030 Sec 8-90 Minimum Elevations for Coastal Infrastructure Within Tidally Influenced Areas

Chair Brotman presented a proposed amendment to recommend the City Commission adopt an amendment to Ordinance Sec 8-90. Amendment was proposed as follows:

"Owners of coastal property in tidally effected areas must at least visually inspect and report signs of seawall failure.

c. All property owners must maintain a tidal flood barrier in good repair. All owners shall be proactive in looking for three warning signs of possible seawall failure which include 1. Blocked Weep Holes which can function as a pressure valve allowing drainage of any water that gets behind a seawall. 2. Voids and/or Sinkholes near the inside edges. Owner must remove grass from edges to expose possible holes. 3. Expanding Concrete Cracks which over time expose steel rebar that will rust and expand thus enlarging cracks."

Chair Brotman motioned to approve. There was no second.

Board member Streeter motioned to continue discussion in the Board's next meeting to finalize the language to be proposed to Commission. Board member Gekhman seconded Board Member Streeter's motion. The motion passed unanimously.
