FINALIZATION AND EXECUTION OF A FIRST AMENDMENT** TO THE **INTERLOCAL** AGREEMENT DATED OCTOBER 1, 2024 BETWEEN THE HBCRA AND THE CITY TO REFLECT THE FOREGOING INCREASED AMOUNT; AUTHORIZING THE EXECUTIVE DIRECTOR TO TAKE ALL STEPS NECESSARY AND APPROPRIATE TO **IMPLEMENT** THE **TERMS AND** CONDITIONS OF THE FIRST AMENDMENT TO THE INTERLOCAL SERVICES AGREEMENT; AND PROVIDING AN **EFFECTIVE DATE.** 

WHEREAS, the Hallandale Beach Community Redevelopment Agency (the "HBCRA") desires that the City of Hallandale Beach (the "City") provide certain direct services consisting of community policing innovations to the HBCRA for Fiscal Year 2024-2025; and

**WHEREAS**, Section 163.400, Florida Statutes, known as Cooperation by Public Bodies, encourages municipalities to do any and all things necessary to aid or cooperate in the planning or carrying out of a community redevelopment plan and related redevelopment activities; and

WHEREAS, on September 25, 2024, the Board of Directors of the HBCRA approved the Interlocal Services Agreement relating to the provision of direct services consisting of community policing innovations by the City to the HBCRA for Fiscal Year 2024-2025, and the HBCRA and City entered into an Interlocal Services Agreement dated October 1, 2024, for such services in an amount not to exceed One Million Eight Hundred Twenty Six Thousand Two Hundred Thirty Seven and 00/100 (\$1,826,237.00); and

**WHEREAS**, due to increased costs for certain services, the HBCRA and the City desire to amend the Interlocal Services Agreement dated October 1, 2024, in the amount of Two Hundred Ninety-Four Thousand Seven Hundred Four and 00/100 Dollars (\$294,704.00) to an amount not to exceed Two Million One Hundred Twenty Thousand Nine Hundred Forty One and 00/100 Dollars (\$2,120,941.00); and

WHEREAS, the Board of Directors of the HBCRA desires to approve (a) an increase to the Interlocal Services Agreement dated October 1, 2024, relating to the provision of direct services consisting of community policing innovations by the City to the HBCRA for Fisal Year 2024-2025 in the amount of Two Hundred Ninety Four Thousand Seven Hundred Four and 00/100 Dollars (\$294,704.00) to an amount not to exceed Two Million One Hundred Twenty Thousand Nine Hundred Forty One and 00/100 Dollars (\$2,120,941.00) and (b) authorize the negotiation, finalization and execution of a First Amendment to the Interlocal Services Agreement dated October 1, 2024 between the HBCRA and the City to reflect the foregoing.
