5                   **A RESOLUTION OF THE MAYOR AND CITY COMMISSION**  
6                   **OF THE CITY OF HALLANDALE BEACH, FLORIDA, FINDING**  
7                   **UNIQUE CIRCUMSTANCES TO AUTHORIZE USE OF**  
8                   **ROBERT HALF INTERNATIONAL, INC. FOR TEMPORARY**  
9                   **STAFFING IN AN ADDITIONAL AMOUNT NOT TO EXCEED**  
10                   **ONE HUNDRED AND SIXTY THOUSAND DOLLARS**  
11                   **(\$160,000) FOR A TOTAL NOT TO EXCEED PURCHASE**  
12                   **ORDER AMOUNT OF THREE HUNDRED AND TWENTY**  
13                   **THOUSAND DOLLARS (\$320,000) FOR FY 2023-24; AND**  
14                   **PROVIDING FOR AN EFFECTIVE DATE.**

16                   **WHEREAS**, Chapter 23, Sec. 28-3 (5), Unique circumstances, of the City of  
17 Hallandale Beach Code of Ordinances provides an exception to the complete bidding  
18 requirement where the City Commission finds unique circumstances to establish that  
19 competitive bidding is not in the best interest of the City; however, such purchases in excess  
20 of \$50,000 shall require a formal, written contract approved by the City Commission; and

21                   **WHEREAS**, the City continues to encounter an unprecedented number of water  
22 meters that are not transmitting electronic reads or the electronic read is inaccurate, which  
23 has resulted in a significant increase in the number of manual reads in the field, meter  
24 maintenance work orders created, and estimated meter reads for billing purposes; and

25                   **WHEREAS**, having utilized the services of Robert Half International, Inc. in 2022,  
26 the Finance Department obtained the services of Robert Half International, Inc. by  
27 purchase order IN 2023, and in December of 2023 received approval through Resolution  
28 2023-147 of a change order to the purchase order agreement in the amount of One  
29 Hundred and Sixty Thousand Dollars (\$160,000) for six months of services but now  
30 requires six additional months throughout FY 2023-24; and

31                   **WHEREAS**, Staff recommends that the Mayor and City Commission find it in the  
32 public interest to approve, pursuant to Sec. 28-3 (5) of the City Code, Unique  
33 Circumstances, expanded temporary staffing services from Robert Half International, Inc. to  
34 assist the Utility Billing Division with additional staffing needs during the implementation of  
35 the city-wide AMI Meter Remediation Project for an additional One Hundred and Sixty

36 Thousand Dollars (\$160,000) for a total not to exceed purchase order amount of Three  
37 Hundred and Twenty Thousand Dollars (\$320,000) for FY 2023-24, and authorize the City  
38 Manager to execute all relating documents.


39 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**  
40 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

42 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

44 **SECTION 2.** The Mayor and City Commission hereby find unique circumstances in  
45 accordance with Sec. 28-3 (5) and authorize a change order increasing the temporary  
46 staffing purchase order with Robert Half International, Inc. by One Hundred and Sixty  
47 Thousand Dollars (\$160,000) to a total not to exceed purchase order amount of Three  
48 Hundred and Twenty Thousand Dollars (\$320,000) for FY 2023-24, and authorize the City  
49 Manager to execute all relating documents.

50 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its  
51 passage and adoption.
