4 A RESOLUTION OF THE MAYOR AND CITY COMMISSION  
5 OF THE CITY OF HALLANDALE BEACH, FLORIDA,  
6 AUTHORIZING AN INCREASE OF THE PURCHASE ORDER  
7 FOR FY 2022-23 WITH VENDOR UNITED RENTALS  
8 UTILIZING SOURCEWELL CONTRACT NO. 062320-URI –  
9 EQUIPMENT RENTAL WITH RELATED SERVICES BY  
10 THIRTY THOUSAND AND THREE DOLLARS (\$30,003), FOR  
11 AN AMOUNT NOT TO EXCEED EIGHTY THOUSAND  
12 DOLLARS (\$80,000); AND PROVIDING AN EFFECTIVE  
13 DATE.

16 WHEREAS, pursuant to Section 23-9 of the City of Hallandale Beach (“City”) Code,  
17 the City Manager shall have the authority to join with other units of government in cooperative  
18 purchasing plans or to purchase pursuant to formal written contracts or competitive bids of  
19 other governmental units, when the best interests of the City would be served, subject to the  
20 requirement that purchases in excess of \$50,000 require City Commission approval; and

22 WHEREAS, pending delivery of new generators on order, Staff has been renting  
23 bypass pumps, heavy equipment, and generators to keep aged City pump stations  
24 operational and minimize any service interruptions utilizing cooperative Sourcewell’s Contract  
25 with United Rentals, Inc.; and

27 WHEREAS, Staff proposes to increase the existing Sourcewell purchase order with  
28 vendor United Rentals utilizing No. 062320-URI – Equipment Rental with Related Services of  
29 Forty-Nine Thousand, Nine Hundred Ninety-Seven Dollars (\$49,997) by Thirty Thousand and  
30 Three Dollars (\$30,003), in an amount that will not exceed Eighty Thousand Dollars (\$80,000)  
31 for FY 2022-2023; and

33 WHEREAS, the Mayor and City Commission find that it is in the best interest of the  
34 residents of the City of Hallandale Beach to mitigate floodings, sanitary sewer overflows, and  
35 maintenance for building repairs by increasing the purchase order for FY 2022-23 with vendor  
36 United Rentals utilizing Sourcewell contract No. 062320-URI – Equipment Rental with  
37 Related Services by Thirty Thousand and Three Dollars (\$30,003), for an amount that will not

exceed Eighty Thousand Dollars (\$80,000), and authorize the City Manager to execute all relating documents.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

**SECTION 1.** The foregoing “Whereas” clauses are incorporated herein.

**SECTION 2.** The Mayor and City Commission hereby authorize increasing the purchase order for FY 2022-23 with vendor United Rentals utilizing Sourcewell contract No. 062320-URI – Equipment Rental with Related Services by Thirty Thousand and Three Dollars (\$30,003), for an amount that will not exceed Eighty Thousand Dollars (\$80,000), and authorize the City Manager to execute all relating documents.

**SECTION 3.** This Resolution shall take effect immediately upon its passage and adoption.
