RESOLUTION NO. 2018-**

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, RATIFYING THE EXPENDITURE OF FIFTY-SEVEN THOUSAND THREE HUNDRED SEVENTY-NINE DOLLARS (\$57,379) TO AMERI-TEMPS EMPLOYMENT SERVICES FOR TEMPORARY LABOR SERVICES IN THE SANITATION DIVISION; AND PROVIDING FOR AN EFFECTIVE DATE.

12 **WHEREAS**, pursuant to Section 23-5 of the City Code of Ordinances, purchases
13 and contracts for equipment, supplies and contractual services in excess of \$50,000
14 require the approval of the City Commission; and
15

16 **WHEREAS**, the City utilizes temporary labor during times of labor shortage to
17 ensure that services are provided in an efficient and cost-effective manner. Landscaping,
18 Construction, Sanitation and Utilities Divisions have benefitted from temporary labor
19 services; and
20

21 **WHEREAS**, the Sanitation Division budgeted \$25,000 for temporary labor services
22 for Fiscal Year 2017-2018; and
23

24 **WHEREAS**, City Administration requested quotes from three vendors: Ameri-
25 Temps, People Ready and Trojan Labor. Ameri-temp's Employment Services provided the
26 sole response, and thereafter provided temporary labor services for the Sanitation Division
27 during Fiscal Year 2017-2018; and
28

29 **WHEREAS**, the Sanitation Division has been operating with multiple and
30 unforeseeable vacant positions during Fiscal Year 2017-2018; and
31

32 **WHEREAS**, as the need for temporary labor persisted, the Sanitation Division
33 increased the initial Purchase Order #2018022 from \$25,000 by \$24,099 on February 8,
34 2018, totaling \$49,099. Ameri-Temps continued to provide services for the City until a
35 more permanent solution could be identified. Four (4) invoices with a total balance of
36 \$8,280 remain outstanding; and

37 **WHEREAS**, the total expenditure to date for Ameri-Temps is fifty-seven thousand
38 three hundred seventy-nine dollars (\$57,379); and

40 **WHEREAS**, City Administration recommends that the City Commission ratify the
41 expenditure of fifty-seven thousand three hundred seventy-nine dollars (\$57,379) to
42 Ameri-temp's employment services for temporary labor services in the Sanitation Division;
43 and

45 **WHEREAS**, the Mayor and City Commission have determined that the City
46 Administration's recommendations are in the best interest of the City and its residents.

48 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY**
49 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

51 **SECTION 1. City Commission Action.** The Mayor and City Commission hereby
52 ratify the expenditure of fifty-seven thousand three hundred seventy-nine dollars (\$57,379)
53 to Ameri-Temps Employment Services for temporary labor services in the Sanitation
54 Division.

55 **SECTION 2. Effective Date.** This Resolution shall take effect immediately upon
56 its passage and adoption.
