A RESOLUTION OF THE CHAIR AND BOARD OF DIRECTORS THE **HALLANDALE** BEACH **COMMUNITY** REDEVELOPMENT AGENCY. HALLANDALE BEACH. FLORIDA; APPROVING THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF HALLANDALE BEACH AND THE HALLANDALE BEACH COMMUNITY AGENCY RELATING TO THE PROVISION OF FUNDS TO THE CITY IN AN AMOUNT NOT EXCEED \$640,000 FOR A LOCAL GOVERNMENT AREA OF OPPORTUNITY LOAN TO PINNACLE AT AUDUBON PLACE, LLLP IN CONNECTION WITH THE DEVELOPMENT OF AN AFFORDABLE HOUSING PROJECT FOR SENIORS AGED 62+ KNOWN AS PINNACLE AT AUDUBON PLACE: AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE THE INTERLOCAL AGREEMENT; AUTHORIZING THE **EXECUTIVE DIRECTOR TO TAKE ALL STEPS NECESSARY** AND APPROPRIATE TO IMPLEMENT THE TERMS AND CONDITIONS OF THE INTERLOCAL AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the mission of the Hallandale Beach Community Redevelopment Agency (the "HBCRA") is to promote and enhance the quality of life by eliminating and preventing slum and blighted conditions in the Community Redevelopment Area through redevelopment activities and projects pursuant to Part III of Chapter 163, Florida Statutes, known as the Community Redevelopment Act of 1969; and

WHEREAS, the 2020 HBCRA Redevelopment Plan Modification requires investments in redevelopment initiatives including affordable housing; and

WHEREAS, to remain efficient and effective and fulfill its affordable housing initiatives, the HBCRA desires to support to development an affordable housing project for seniors aged 62+ known as Pinnacle at Audubon Place to be developed by Pinnacle at Audubon Place, LLLP (the "Developer"), which support shall be in form of funding for a Local Government Area of Opportunity Loan to be made by the City of Hallandale Beach (the "City") to the Developer in an amount not to exceed Six Hundred Forty Thousand and 00/100 Dollars (\$640,000.00); and

WHEREAS, Section 163.400, Florida Statutes, known as Cooperation by Public Bodies, encourages municipalities to do any and all things necessary to aid or cooperate in the planning or carrying out of a community redevelopment plan and related redevelopment activities; and

WHEREAS, the Board of Directors of the HBCRA desires to approve the Interlocal Agreement relating to the provision of funding by the HBCRA to the City for a Local Government Area of Opportunity Loan to be made by the City to the Developer in an amount not to exceed Six Hundred Forty Thousand and 00/100 Dollars (\$640,000.00) for the affordable housing project for seniors aged 62+ known as Pinnacle at Audubon Place.

Execution of Interlocal Agreement. The Executive Director is hereby 53 authorized to execute the Interlocal Agreement. 54 55 Section 4. Implementation of Interlocal Agreement. The Executive Director is hereby authorized to take all steps necessary and appropriate to implement the terms and conditions of 56 the Interlocal Agreement including, but not limited to, the HBCRA making payments to the City. 57 Section 5.
