**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA AWARDBID # FY 2024-2025-03 TO LOU'S POLICE DISTRIBUTORS, INC. IN AN AMOUNT OF NINETY SEVEN THOUSAND TWO HUNDRED THIRTY (\$97,230) TO PURCHASE GLOCK FIREARMS WITH RED DOT SIGHT TECHNOLOGY, HOLSTERS, AND ACCESSORIES TO REPLACE ALL FULL-SIZE PISTOLS FOR THE POLICE DEPARTMENT; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all purchases of and contracts for equipment, supplies and contractual services, when the estimated cost shall exceed \$50,000 shall be based on competitive bids, and pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager shall have the authority to recommend to the City Commission award of contracts; and

**WHEREAS**, on October 23, 2024, the City issued an Invitation to Bid # FY 2024-2025-03, City of Hallandale Beach Police Department Purchase of Glock Firearms and Accessories and Trade-In-Allowance, to purchase Glock firearms with red dot sight technology and accessories to replace all full-size pistols for the Police Department; and

**WHEREAS**, studies on the use of red dot sight technology have demonstrated significant improvements in shooting accuracy and a reduction in the number of rounds needed to hit a target; and

**WHEREAS**, two (2) vendors responded to the solicitation, and upon review, Staff determined that Lou's Police Distributors, Inc. was the lowest responsive bidder with a final tabulated amount of Ninety Seven Thousand Two Hundred Thirty Dollars (\$97,230), after a trade-in allowance for existing city inventory of Thirty-Two Thousand Seven Hundred Sixty Five Dollars (\$32,765); and

**WHEREAS**, Staff recommends that the Mayor and City Commission award Bid # FY 2024-2025-03 to Lou's Police Distributors, Inc. in an amount of Ninety Seven Thousand Two

37 Hundred Thirty Dollars (\$97,230) to purchase Glock firearms with red dot sight technology,  
38 holsters, and accessories to replace all full-size pistols for the Police Department, and  
39 authorize the City Manager to execute relating documents.

46 **SECTION 2.** The Mayor and City Commission hereby award Bid # FY 2024-2025-03  
47 to Lou’s Police Distributors, Inc., in an amount of Ninety Seven Thousand Two Hundred Thirty  
48 Dollars (\$97,230) to purchase Glock firearms with red dot sight technology, holsters, and  
49 accessories to replace all full-size pistols for the Police Department and authorize the City  
50 Manager to execute relating documents.

52 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its  
53 passage and adoption.
