**RESOLUTION NO. 2016 - 182**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDING ITB #FY2015-2016-021, SIDEWALK REPAIR AND OTHER RELATED SERVICES TO THE LOWEST RESPONSIVE, RESPONSIBLE, BIDDER METRO EXPRESS, INC. IN AN AMOUNT NOT TO EXCEED ONE HUNDRED THIRTY THREE THOUSAND SIX HUNDRED TWENTY FIVE (\$133,625.00) DOLLARS; AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT AND ALL RELATED DOCUMENTS TO EFFECTUATE THE PROJECT WITH METRO EXPRESS, INC.; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all purchases of and contracts for equipment, supplies and contractual services, when the estimated cost shall exceed \$50,000.00 shall be based on competitive bids. Furthermore, pursuant to Chapter 23, Section 23-6, Award of Contract, the City Manager, shall have the authority to recommend to the City Commission award of contracts; and

**WHEREAS**, the City has a legal obligation to repair changes of elevation that may occur on walking surfaces in the right-of-way; and

**WHEREAS**, the City has paid out approximately eighty one thousand five hundred (\$81,500) dollars in sidewalk injury lawsuits over the course of the last three (3) years; and

**WHEREAS**, during 2013, the City instituted a sidewalk replacement program to repair broken sidewalks throughout the City, and staff intends to continue the current sidewalk repair program and aims to complete all sidewalk repairs by the end of FY2017-2018; and

**WHEREAS**, by this time, it is anticipated that all sidewalk change in elevation issues that exist today will be repaired; and

**WHEREAS**, on July 28, 2016, the City released Invitation to Bid #FY 2015-2016-021, Sidewalk Repairs and Other Related Services, to two hundred seventy one (271) vendors via email. It was also sent to the Hallandale Beach Chamber of Commerce, posted on Facebook/Twitter and four (4) Minority Business Development Agencies; and

**WHEREAS**, the City released this bid seeking bids from licensed contractor(s) for a three (3) year contract on an as needed basis in order to provide various disciplines: pour concrete, protection of storm drains, concrete curb and gutters; tree removal and preservation, sod installation, asphalt pavement; irrigation; fencing installation/repairs, sign relocation; utility box adjustment, pressure cleaning; and

**WHEREAS**, on August 8, 2016, a non-mandatory pre-bid meeting was held, and only one (1) vendor attended the meeting; and

**WHEREAS**, bids were due on August 29, 2016, and three (3) bids for ITB FY#2015-2016-021 were received; and

**WHEREAS**, based upon the fact that Metro Express submitted the lowest, responsive, responsible bid, City Administration is recommending the award of ITB #FY2015-2016-021 be awarded to Metro Express, Inc.; and

**WHEREAS**, the City Administration recommends that the City Commission award ITB FY #2015-2016-021, Sidewalk Repairs and Other Related Services for an amount not to exceed one hundred thirty three thousand six hundred twenty five (\$133,625.00) dollars; The City Administration further recommends authorization for the City Manager and City Attorney to negotiate and execute an agreement with Metro Express, Inc.; and

**WHEREAS**, the Mayor and City Commission have determined that the City Administration's recommendations are in the best interest of the City and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

**SECTION 1. City Commission Action.** The Mayor and City Commission hereby award ITB #FY2015-2016-021, Sidewalk Repairs and Other Related Services to the second lowest, responsive, responsible bidder, Metro Express, Inc.

**SECTION 2. City Manager and City Attorney Authorization.** The Mayor and City


74 Commission hereby authorize the City Manager and City Attorney to negotiate and execute an  
75 agreement with Metro Express, Inc. for an amount not to exceed one hundred thirty three  
76 thousand six hundred twenty five (\$133,625.00) dollars. The City Manager is further authorized  
77 to execute all related documents to effectuate this project.
