A RESOLUTION OF THE BOARD OF DIRECTORS OF  
THE GOLDEN ISLES SAFE NEIGHBORHOOD  
DISTRICT OF THE CITY OF HALLANDALE BEACH,  
FLORIDA, AUTHORIZING UTILIZATION OF MIAMI-  
DADE COUNTY CONTRACT NO. RFP-00188D WITH  
SECURITY ALLIANCE, LLC, FOR SECURITY GUARD  
SERVICES, IN AN AMOUNT NOT TO EXCEED TWO  
HUNDRED SIXTY SEVEN THOUSAND EIGHT  
HUNDRED FORTY SIX DOLLARS (\$267,846); AND  
PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, pursuant to Chapter 23, Section 23-8 Exception to Bid Requirements, (6) Bids and Contracts from Other Entities, the City Manager is authorized to procure supplies, materials, equipment, and services from other governmental units, when the best interests of the City would be served subject to the requirement that any purchase in excess of \$50,000 requires City Commission approval; and

**WHEREAS**, Miami-Dade County's competitively bid RFP-00188D for security guard services resulted in an agreement with Security Alliance, LLC, which began in September 2017 and was renewed through August 31, 2026; and

**WHEREAS**, the Golden Isles Safe Neighborhood District (GISND) has a Level I Unarmed Guard posted at the Layne Boulevard guardhouse twenty-four (24) hours a day, seven (7) days a week, and on September 26, 2023, the Board of Directors approved Resolution 2023-008 authorizing utilization of Miami-Dade County Contract No. RFP-00188D with Security Alliance, LLC, to provide security guard services at GISND; and

**WHEREAS**, on October 28, 2024, the GISND Advisory Board recommended utilizing funds to continue providing the same security services through Security Alliance, LLC for a period of twelve months, as procuring security services through an outside vendor is more cost-effective than the annual salary and benefits of uniformed community service aids previously assigned to this location.

41           **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

43           **SECTION 2.** The Board of Directors hereby authorize utilization of Miami-  
44 Dade County's Contract No. RFP-00188D for security guard services to enter into an  
45 agreement between the GISND and Security Alliance, LLC in an amount not to exceed  
46 Two Hundred Sixty Seven Thousand Eight Hundred Forty Six Dollars (\$267,846); and  
47 authorize the City Manager to execute all related documents.

49           **SECTION 3. Effective Date.** This Resolution shall take effect immediately  
50 upon its passage and adoption.
