### **Short Title:**

A RESOLUTION OF CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE BEACH COMMUNITY REDEVELOPMENT AGENCY, HALLANDALE BEACH, FLORIDA, RESCINDING THE AWARD OF A COMMERCIAL FAÇADE IMPROVEMENT GRANT IN THE AMOUNT OF \$100,000, A COMMERCIAL INTERIOR RENOVATION GRANT IN THE AMOUNT OF \$90,000, A COMMERCIAL KITCHEN GRANT IN THE AMOUNT OF \$300,000 AND A TENANT LEASE SURETY/TENANT RENT SUBSIDY IN THE AMOUNT OF \$7,864 TO AARONSHOSH INVESTMENTS LLC FOR THE RENOVATION OF THE PROPERTY LOCATED AT 129 N.E. 1<sup>ST</sup> AVENUE, HALLANDALE BEACH, FLORIDA; AND PROVIDING AN EFFECTIVE DATE; PROVIDING FOR CONFLICTS.

## **Staff Summary:**

## **Background:**

On June 17, 2019 the HBCRA Board of Directors awarded a Commercial Incentive Grant package to Aaronshosh Investments LLC, in the amount of \$497,864. This Commercial Incentive Grant package included funds for a Façade and interior renovation grant and a commercial kitchen grant to aid in the development of a Microbrewery.

## **Current Situation:**

Since the approval the HBCRA has made every effort to work with Aaronshosh Investments, LLC. to negotiate and execute an agreement. On September 14, 2019 Executive Director, Dr. Jeremy Earle, informed the Board that the HBCRA and Aaronshosh Investments, LLC. were unable to come to an agreement.

#### **Recommendation:**

HBCRA Staff recommends that the HBCRA Board of Directors approve the resolution authorizing the rescission of the Commercial Incentive Grant package in the amount of \$497,864 for Aaronshosh Investments, LLC.

#### Why Action is Necessary

Pursuant to the HBCRA Commercial Investment Program Policy all applications must be presented to the HBCRA Board of Directors for approval and rescission.
