## **Short Title:**

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE UTILIZATION OF STATE OF FLORIDA CONTRACT #600-000-11-1 WITH TOSHIBA BUSINESS SOLUTIONS FOR THE LEASE OF COPIERS AND THE PURCHASE OF SUPPLIES, AND MAINTENANCE SERVICES FOR ALL COPIERS FOR AN AMOUNT NOT TO EXCEED ONE HUNDRED FIVE THOUSAND FOUR HUNDRED FIFTY SIX (\$105,456.00) DOLLARS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS TO EFFECTUATE THE PURCHASE AS PROVIDED FOR IN FISCAL YEAR 2017-2018 BUDGET; AND PROVIDING AN EFFECTIVE DATE.

## Staff Summary:

#### Background:

Each fiscal year, the Procurement Department facilitates the purchase of specific commodities that the City procures annually through cooperative purchasing. The City is able to participate in and utilize competitively solicited contracts to obtain the best goods/services and pricing available in the market.

For FY 17/18 the City of Hallandale Beach will be participating in the Florida Department of Management Services, State of Florida Contract # 600-000-11-1 with Toshiba America Business Solutions, Inc., for lease of multifunction devices (copiers) and purchase of supplies and maintenance services for all multifunction devices and printers.

The term of the contract renewal is from August 4, 2017 through August 3, 2018, Amendment No. 5.

The City has been utilizing the Toshiba Agreement since 1990 with superb customer service and equipment.

#### Current Situation:

The City, through the State of Florida Contract # 600-000-11-1, will use the Toshiba America Business Solutions, Inc., Contract for lease of multifunction devices and related services.

Each Department utilizes the services through the Procurement Department. The Procurement Department manages the contract. See attached Exhibit 3 Lease Multifunction Device Inventory for the City.

The City's expenditures with this vendor for the last three (3) years are as follows:

- 1. FY 14/15 \$59,410
- 2. FY 15/16 \$89,261
- 3. FY 16/17 \$101,367 through 8-30-17 \*

\*Invoices to be paid through 9-30-2017 will make the expenditures over \$107,000 for FY 16-17.

For FY 17/18, the following expenditures for the use of lease of copiers and related services for <u>Toshiba America Business Solutions</u>, Inc., as follows:

Leases includes all parts, labor, services calls and toner supplies for each multifunction device. Lease does not include multifunction paper and staples.

### Why Action is Necessary:

Pursuant to Chapter 23, Section 23-9. - Cooperative Purchasing, and Section 23-8 (6) Bids and Contracts from other entities, the City Manager may procure, without following formal contract procedure, all supplies, materials, equipment and services and the City Manager is authorized to use competitive bids and formal contracts from other entities, when the best interest of the City would be served.

#### Fiscal Impact:

As per the approved FY 17/18 budget, by department, expenditures are not to exceed \$105,456 with Toshiba America Business Solutions. Inc., utilizing the State of Florida Contract # 600-000-11-1.

## **Proposed Action:**

Staff recommends approval of the attached Resolution authorizing the City Manager to execute all related documents to effectuate the lease of copiers and purchases of supplies, and maintenance services for all multifunction devices and related services for the FY 17/18 with Toshiba America Business Solutions, Inc., in accordance with City's policies and procedures.
