5 **A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF**
6 **THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING**
7 **A CHANGE ORDER TO THE CONTRACT PRICE FOR SCHOOL**
8 **CROSSING GUARD SERVICES WITH WATERFIELD FLORIDA**
9 **STAFFING, LLC DBA ACTION LABOR, DBA STAFFING**
10 **CONNECTION IN AN AMOUNT NOT TO EXCEED FORTY-NINE**
11 **THOUSAND, AND FIFTY-TWO DOLLARS (\$49,052);**
12 **PROVIDING FOR AN EFFECTIVE DATE.**

14 **WHEREAS**, on October 14, 2020, the Hallandale Beach City Commission adopted
15 Resolution 2020-089 awarding Waterfield Florida Staffing, LLC DBA Action Labor, DBA Staffing
16 Connection (“Vendor”) Contract FY2019-2020-00, a 5-year agreement to provide school crossing
17 guard services in an amount not to exceed three hundred and five thousand five hundred and ten
18 dollars (\$305,510); and

20 **WHEREAS**, since the adoption of the City of Hallandale Beach’s (“City”) current contract,
21 “Florida Amendment 2 of 2020 – Raising Florida’s Minimum Wage” passed raising the annual
22 minimum wage and thus affecting the cost of labor for the Vendor; and

24 **WHEREAS**, pursuant to Code of Ordinances, Chapter 23, Section 23-12 Procedures for
25 purchases in excess of \$50,000, item (7)(a) Change Orders, any change in the contract price,
26 scope of work or time of for completion of any project following the award of a contract shall be
27 by a written change order, the scope of any project may not be changed without prior approval of
28 the City Commission, and no change order shall materially change the scope of work unless
29 approved by the City Commission; and

31 **WHEREAS**, Staff recommends the City Commission approve a change order to the
32 contract price for school crossing guard services with the Vendor in an amount not to exceed
33 forty-nine thousand, and fifty-two dollars (\$49,052), for a new not to exceed total amount of three
34 hundred fifty-four thousand, five hundred and sixty-two dollars (\$354,562), and authorize the City
35 Manager to execute all relating documents.

37 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
38 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**


40 **SECTION 1. Recitals.** The foregoing recitals are true and correct and incorporated

42 **SECTION 2. Authorization.** The Mayor and City Commission hereby authorize a change
43 order to the contract price for school crossing guard services with the Vendor in an amount not to
44 exceed forty-nine thousand, and fifty-two dollars (\$49,052), for a new not to exceed total amount
45 of three hundred fifty-four thousand, five hundred and sixty-two dollars (\$354,562), and authorize
46 the City Manager to execute all relating documents.

48 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its
49 passage and adoption.
