Short Title:

A DISCUSSION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, CONFIRMING CANDIDATE PROJECTS FOR THE BROWARD METROPOLITAN PLANNING ORGANIZATION’S (MPO) METROPOLITAN TRANSPORTATION PLAN (MTP).

Staff Summary:

Background:

The Broward MPO is a federally-mandated agency that is responsible for making policy on local transportation issues and deciding how to allocate federal money for transportation projects within Broward County. The Broward MPO has begun development of its Metropolitan Transportation Plan, Commitment 2045. The plan allocates funding to maintain and improve Broward's transportation system now and in the future. The plan serves as the basis for identifying priorities and transportation projects that will be implemented as soon as six years and through 2045.

City staff developed a proposed list of 24 city-wide transportation projects which was shared with the City Commission on April 5, 2018 for input and to provide any additional projects they wished to see funded and included in the list. After receiving City Commission comments on the list, staff started the conversation to fund the projects list with the Broward MPO on April 9, 2018 in a face to face meeting.

The meeting, which Mayor London -- as the City's MPO Board Member -- attended by phone, was a collaborative process between MPO and city staff with a focus on which of the 24 projects are suitable to be included in the Commitment 2045, Metropolitan Transportation Plan. The MPO has committed to working with the City to identify funding/programs for all projects proposed on the list. Of the 24 projects, 14 were identified as being more suitable to receive funding from the MPO's Complete Streets and other Localized Initiatives Program (CSLIP). The remaining 10 projects were discussed in more detail and the MPO recommended for city staff to meet with the Florida Department of Transportation (FDOT) and the MPO's Complete Streets Master Plan team.

Follow-up meetings were held to discuss the remaining 10 projects with FDOT on April 18, 2018 and the MPO's Complete Streets Master Plan team on April 26, 2018. As a result, the list was further refined to 5 candidate projects (Exhibit 1).

City staff will represent to the MPO staff that there is consensus by the City Commission.

Why Action is Necessary:

Federal law requires the Broward MPO (and MPO's across the country) to update their Metropolitan Transportation Plan every five years. Commitment 2040, the previous MTP was adopted by the MPO Board in December 2014. Work on Commitment 2045, the update of Commitment 2040, began in December 2017 and will be completed in 2019 with adoption of the final plan by the Broward MPO. Projects included as part of Commitment 2045 can be completed in as little as six years, depending on funding availability. Commitment 2045 will be starting with a clean slate of projects – no projects will be carried over from previous plans (including Commitment 2040). Commitment

2045's "Call for Projects" deadline is June 1, 2018. Projects submitted will be included into the MTP Needs Assessment.

The Broward MPO has asked the City to internally discuss and refine their list of projects for submittal to the Broward MPO by May 4, 2018. Upon review of final project list, the Broward MPO will send a link to the City for the formal, electronic submittal of projects prior to the June 1, 2018 deadline.

Proposed Action:

City Staff recommends the Mayor and City Commission support the candidate projects for the Broward Metropolitan Planning Organization's (MPO) Metropolitan Transportation Plan (MTP). This consensus will demonstrate that the City is behind these projects and will help in funding the priorities.
