Dixie Highway & 1st Avenue Corridor Vision

Vision Statement

Hallandale Beach is committed to implementing complete streets throughout the City. Complete streets are streets that accommodate multiple transportation modes and are safe for everyone, regardless of age, ability, income, race, or ethnicity. Dixie Highway and NE 1st Ave is a historic and vital roadway corridor in Hallandale Beach. The City envisions this corridor to be the living room that connects East and West Hallandale Beach as one. A corridor that fosters economic development, safety, and improved public health. The City's Fashion Art Design District and Purposed Transit-Oriented Development are both located along this corridor. This corridor also serves as a gateway to the City providing access from Miami Dade County and Hollywood. Repurposing this corridor is not about removing access but, granting access to new opportunities and existing needs. The creation of dedicated bicycle lanes, wider sidewalks, landscape buffers, and on-street parking are all features in the City's Vision to revitalize the corridor and activate it as a vibrant mixed-use commercial corridor which unites the City, and balances multimodal transportation options to reduce single occupancy vehicle dependency.

- Provide parking




Broward MPO & City of Hollywood

The Dixie Highway corridor was selected from County Line Road to Sheridan Street as a priority project in the Broward Metropolitan Planning Organization's Complete Streets Master Plan. This is a collaborative effort with our neighboring city to the south, The City of Hallandale Beach. The vision for this area is to repurpose travel lanes to create a complete streets environment. Our consultant, Kimley-Horn and Associates has completed a traffic study which demonstrates the lane elimination will not cause any adverse impacts to the study area, and no overcapacity roadways will receive 3% or more of its capacity as a diversion from the corridor due to the lane elimination.

FADD and Coastal Link Station

Fashion Arts Design Sub-District

The Fashion/Art/Design subdistrict is intended to be a unique, lively arts and commerce area accommodating a wide range of uses including residential, retail, art, culture, and design. FADD runs along NE 1st Avenue from Hallandale Beach to NE 5th Street. FADD is to become a forward-thinking district, continually improving the quality of life for and creating a sense of pride amongst residents, provide comfortable and exciting pedestrian environment, inviting open spaces, hosting events for families and children, initiating a mix of cultural and entertainment facilities, and offering a refined urban living experience in a charming setting.

Coastal Link Station

Hallandale Beach has been identified for potential commuter rail service through the proposed Florida East Coast (FEC) Coastal Link Station. The new 85-mile commuter rail service from Miami to Jupiter planned to serve as an integrated extension of the existing South Florida Regional Transit Authority's Tri-Rail service. This station would share tracks with FEC freight trains and VirginTrains (Brightline) intercity passenger service. The proposed location of the station is along NE 1st Avenue and SE 4th Street. Couple with the City's land-use regulations and growth patterns, this station would allow most commuter passengers the ability to walk, bike, or take transit to their destinations, decreasing car dependency.

Supportive Material

Walk audit

The Hallandale Beach Walking Audit brought together a diverse group of participants on Saturday, March 30, 2019, to evaluate Dixie Highway/N/S 21st Avenue/NE/SE 1st Avenue from County Line Road to Sheridan Street. The Walking Audit provided an experiential, hands-on exercise that evaluated the walking environment; identified pedestrian (and bicyclist) issues such as safety, access, connectivity, comfort, and convenience. This exercise allowed the creation of the Walking Audit Report, which concluded recommendations for short-term, intermediate, and long-term projects to help the City realize its vision for the area.

Mobility Roadmap

The City of Hallandale Beach Mobility Roadmap was released on November 5th, 2018. The report's goals were to develop a "roadmap" of recommended transportation solutions, cost estimates, funding strategies, and an implementation plan that will help guide the City regarding capital transportation investments over the next 20 years. The report analyzed the existing infrastructure, current plans, and future mobility project. The roadmap suggested an enhancement to existing bike lanes by painting them green. The report also recommends adding additional on-street parking throughout the Reginal Activity Center (RAC) Districts. The Mobility Roadmap calls for implementing lane repurposing along NE/SE 1st Avenue and shared use paths for bicycles and pedestrians along the FEC corridor.

Citywide Master Plan

The Citywide Master Plan made recommendations for reshaping the City of Hallandale Beach into a more pedestrian-oriented, mixed-use, and sustainable community. It includes regulatory and capital improvement initiatives in three general categories: Built Environment, Natural Environment; and Policy and Regulatory Framework. An objective in the City's Master Plan is to limit further roadway capacity improvements that diminish the pedestrian environment and sense of place. Another is to expand local bus service between town, district, and neighborhood centers as they are established. The plan realized that creating a citywide network of visually and functionally strong pedestrian connections will ensure that roadways equally serve vehicles, buses, bicyclists, and pedestrians.

Regional Activity Center

The Regional Activity Center (RAC) land use was adopted by the City Commission on July 21, 2010 in accordance with the City's Comprehensive Plan. The Hallandale Beach Comprehensive Plan calls for the City to direct development and redevelopment to areas adjacent to major transportation corridors within the designated RAC, such as Dixie Highway and NE/SE 1st Ave. The corridor falls completely within the Central and West RAC subdistricts. The Central RAC and more specifically the RAC Corridor subdistrict is the most intense subdistrict in the RAC, accommodating destinations as well as residential uses. Located along wide, existing commercial corridors, this subdistrict has the largest scale of redevelopment and creates a vibrant, pedestrian-friendly, mixed-use district along main transit routes, near the planned Coastal Link Station.

Sustainability Action Plan

The Sustainability Action Plan aims to improve the quality of life for all in the community while protecting the environment, assuring continued prosperity and developing the resilience needed to face future challenges. The Sustainability Action Plan set short-term goals to meet by 2022 and long-term goals to meet by 2040. Some of the goals set for the city was to reduce the consumption of gasoline/diesel fuels, increase bikeshare, and build-out bicycle & pedestrian Infrastructure to decrease vehicle miles traveled.

Transportation Master Plan

The Transportation Master Plan explores the issue of traffic congestion throughout the City's roadway network but does not rely solely on addressing these issues with only roadway transportation improvement solutions. The plan identifies alternative recommended projects to improving the traffic congestion through transportation system management and multimodal solutions. The plan listed recommended improvements for the City such as:

- Implement Bike Lanes and Sidewalks included with Future Roadway Improvements on all Arterials and Collectors
- Implement Crossing Countdown Signal Heads at all Traffic Signals with 2 or More Lanes
- Implement Bike Parking at Public Buildings and Major Destinations
- Install Adequate Lighting along Bike/Ped Routes
- Implement City-wide Bike and Pedestrian Signage

Basis of Design Report

The Basis of Design Report for the City of Hallandale Beach provides preliminary master planning for the future implementation of infrastructure improvements. Such improvements that were outlined for roadways and sidewalks called for bicycle lanes, parallel parking along retail/commercial areas, street lighting, and ADA access ramps for sidewalks.

Closing Summary

The City has shifted its focus from auto dependency to a more balanced multimodal transportation network. In each of the plans mentioned above the City has reaffirmed its commitment to implementing complete streets and its vision for the Dixie Highway NE/SE 1st Avenue corridor. A vibrant, equitable, safe, and connected corridor that delivers Progress, Innovation, and Opportunity to all users in Hallandale Beach.

16 17	WHEREAS, a complete street is a street where the entire right-of-way is planned,
18	designed, and operated for all modes of transportation and users regardless of age or ability; and

20	WHEREAS, the Broward Metropolitan Planning Organization ("MPO") Complete Streets
21	and other Localized Initiatives Grant Program ("CSLIP") provides funding for small local
22	transportation projects which improve the safety and mobility for transportation users in Broward
23	County; and

25	WHEREAS, the MPO developed a Complete Streets Master Plan to guide future
26	investments by creating a prioritized list of projects based on technical, data-driven analysis and
27	community input; and

29	WHEREAS, this project is on the MPO priority list and has also been identified in the City's
30	Mobility Roadmap, a City Commission adopted multimodal transportation plan; and

32	WHEREAS, the City is submitting a CSLIP application to enhance the bicycle and
33	pedestrian connectivity along Dixie Highway and NE/SE 1 st Avenue within public right-of-way,
34	from County Line Road to Pembroke Road; and

36	WHEREAS, the City endorses the Florida Department of Transportation ("FDOT")
37	delivering the project on the City's behalf, fully administering the design and construction of the
38	project; and

40	WHEREAS, since this is an Off State Highway System Project, FDOT will not provide
41	maintenance for the project segment after construction is completed; and

43	WHEREAS, if approved a Maintenance Agreement will be required to establish the City
44	as the maintaining agency for the segment; and

46	WHEREAS, the Mayor and the City Commission understand it is the responsibility of the
47	City to maintain the right-of-way after the project's completion; and

49	WHEREAS, the Mayor and City Commission hereby endorse the Broward MPO's
50	proposed project to enhance bicycle and pedestrian connectivity along Dixie Highway and NE/SE
51	1 st Avenue within public right-of-way, from County Line Road to Pembroke Road;

53	NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF
54	THE CITY OF HALLANDALE BEACH, FLORIDA:

56	<u>SECTION 1.</u> The foregoing "whereas" clauses are incorporated herein.

58	SECTON 2. Endorsement and Authorization. The Mayor and the City Commission of
59	the City of Hallandale Beach, Florida, hereby endorse an application to the Broward MPO seeking
60	grant funding under the CSLIP for the proposed project identified and prioritized as part of the
61	Complete Streets Master Plan (CSMP) within the City of Hallandale Beach, including bicycle and
62	pedestrian improvements along Dixie Highway and N/SE 1 st Avenue within public right-of-way,
63	from County Line Road to Pembroke Road. The City endorses the FDOT delivering the project
64	on the City's behalf and the City's obligation to provide maintenance thereafter. The City Manager
65	is authorized to execute all necessary documents to submit applications and implement the
66	project if awarded.

68	SECTION 3. Effective Date. This resolution shall be effective immediately upon its
69	adoption.
