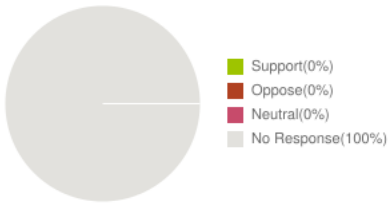

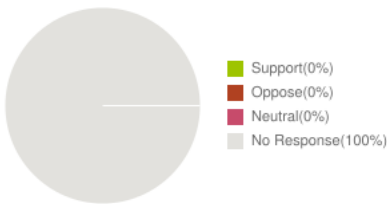

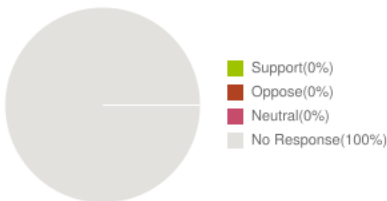

At a time of severe economic crisis, when our most vulnerable residents are suffering from loss of income, unemployment, homelessness, crushing debt and the loss of their loved ones, we ask that you reallocate 10% of the police department budget towards rental relief, affordable housing, mental health services and alternatives to incarceration such as Diversion Programs. Hallandale should follow the example BSO set in the 2008 economic crisis, when it made a 7% budget cut for voter-mandated property tax relief.

When we say Defund the Police we are not abandoning our communities to violence we want to redirect and reallocate those funds to mental health support, health care, housing, and jobs that pay a livable wage. This is what truly keeps a community safe. A significant portion of what we call crime is poverty-related. We need to decriminalize poverty. We want safe communities, of course, and the police have not brought us that safety. There are so many solutions on how to intervene in violence (there are trauma response centers, there's restorative justice, there's community education, and curriculum we could use to prevent situations before they array) however these solutions are usually underfunded and unable to get off the ground.

Our budget is a statement of our priorities and should reflect a commitment to support and provide relief during this time. True public safety lies in the economic, social, health and safety of all our communities, which can only be achieved through direct investment in the community itself. We would appreciate your feedback and partnership as we continue to navigate this crisis and plan for recovery during this critical budget cycle.
